advised SA WILLIAM H. LAWRENCE that earlier on that date an individual believed by him to be SAMUEL CARTER, Negro student, LeMoyne College, and one of the black power group at LeMoyne (according to reliable information furnished 11/21 and 11/22/67 by SA LAWRENCE), had been thrown out of the Firestone Union Hall earlier on that date when he attempted to make a black power talk. Some of the officials of the American Federation of State, County and Municipal saying they did not want any racist tint to be attached to the strike. It is noted that earlier on 2/26/68 and SA LAWRENCE observed SAMUEL CARTER in the protest march held on Main Street in Memphis.

also advised that Rev. RICHARD M. MOON Memphis State University, has become active in the strike and is one of the few white ministers working with the Memphis Ministerial Alliance, a Negro body, which is primarily coordinating the strike sympathy activities.

One of the more militant Negro leaders engaged in this activity, according to is Rev. EZEKIEL BELL, Tennessee, and BELL and MOON both indicated a recent conversation that they had attended theology
