On 4/15/68, SAC ROBERT G. JENSEN advised that he had received a call at 11:25 A.M., 4/15/68, from Assistant Director WILLIAM C. SULLIVAN, Domestic Intelligence Division of the FBI, to the effect that one Dr. DUDLEY WARD of the Methodist Center located on Capitol Hill, Washington, D. C. (apparently a lobbyist and national official of the Methodist Church) had advised the Bureau that he was most concerned about Rev. JAMES MORRIS LAWSON, JR., Pastor, Methodist Church, 653 Austin Street, Memphis, to the effect that he understood based on stodess upon and for which no basis in fact was furnished, that LAWSON will be the next prominent Negro civil rights leader to be murdered in the United States as a sequel to the 4/4/63/01 Dr. MARTIN LUTHER KING, JR.

Assistant Director SULLIVAN has requested the Memphis FBI to (1) advise the Memphis PD of this fact and (2) to advise LAWSON and determine from him if he has, in fact, received any personal threats and if so from whom if he is aware as to their identity.

At approximately 12:30 P.M., 4/15/68, SA
LAWRENCE furnished the information concerning the
concerning of Methodist church leaders regarding
the welfare of LAWSON. SA LAWRENCE was advised
that a memo would be prepared for the Homicide
Division and for COP JAMES C. Macdonald to this
effect. Also immediately thereafter, the writer
attempted to call LAWSON at his church. His secretary
advised that he was not there, that he was probably
at home, and he probably would be scheduled to return
to the church at about 2 P.M.

The writer introduced himself, gave his full name and phone number of the office, and asked that she have LAWSON call the writer as early as possible as the matter was quite important. She stated she would do so.

Thereafter, the writer called LAWSON's residence and spoke to a woman who introduced herself as his wife. She stated LAWSON had just left to go to one of the Memphis radio or television stations for some sort of conference, and that she would have him call the writer as soon as she made contact with him. As of the late afternoon of 4/15/68, LAWSON had not returned the call.

SAC JENSEN in an afternoon conversation on 4/15/68 with GEORGE C. MOORE, Section Chief, Domestic Intelligence, advised Mr. MOORE of the efforts of the writer to locate LAWSON, and it was pointed out that it was not felt necessary to make any fugitive type or repeated efforts to contact LAWSON

as LAWSON is an intelligent person, that he personally knows the writer, and that he knows how to use the telephone.

It will be noted that the 4/12/68 issue of the Memphis newspaper, The Commercial Appeal, reported that LAWSON at a press conference for the Community on the Move for Equality of which he is chairman of the strategy committee had blasted "the Momphis PD and Federal law enforcement agencies, including the FBI, stating that he did not feel states that it was in their best interests to find the killer of Dr. KING. He did not elaborate. During this same press conference, LAWSON and Rev. SAMUEL B. KYLES, Pastor, Monumental Baptist Church, according to a story in the Memphis Press-Scimitar newspaper, 4/12/68 issue, page one, by reporter CLARK PORTEOUS, both LAWSON and KYLES blasted the Memphis PD, accused it of engaging in police brutality, accused it of stealing money from Negroes stopped for questioning, and accused it of harassing people during the recent curfew following the murder of Dr. KING. LAWSON claimed that police brutality would be the next major issue taken up by the abovementioned COME group after the sanitation strike currently in progress ends.

It is significant to note that in another investigation, the MURKIN case (killing of Dr. KING ME 44-1987), SA LAWRENCE attempted to contact Rev. KYLES on 4/15/68 for the purpose of interviewing him inasmuch as it has been determined that he was registered in the Lorraine Motel on 4/3-4/68 when Dr. KING was registered there, and that his wife tersely stated that he was out of town and would not be back until 4/20/68 and refused to furnish information concerning his current location in order that he might be interviewed by another field division.

The actions circumstantially on the part of LAWSON and KYLES would tend to indicate there bitterness toward all law enforcement and their

refusal to cooperate in matters of mutual interest, and to discharge their civic responsibility as citizens of this country. It is felt that this information should be made a matter of record for future reference.

arrested 4/5/68 by the Memphis PD on disorderly conduct charge when he and over 100 other persons refused to leave the Memphis City Hall after appearing to protest the treatment of the sanitation workers and on 4/15/68, Inspector H. L. MC ADEN, Memphis PD, advised LAWSON has Memphis PD FBI DOB, 9/22/28; POB, Uniontown, Pennsylvania.
