Inastruch as you have been designated by the Secretary as the DoD point of contact for the House Select Committee on Assassinations we want to ensure you have the benefit and are exare of work already accomplished by the investigative services and DIA in complying with references (b) and (c).

The DIA, Air Force OSI and Naval Investigative Service responses to references (b) and (c) have been completed and are included as attachments to references (e), (f), and (g). Inastruch as Army investigative files responding to (b) and (c) were so voluminous we advised the

your Select Counts on Overs.

General Counsel that Army intended to invite Committee staffers to review these files in a room set aside for them at the Pentagon. Copies of DoD documents desired by the Committee were to be provided along with indices of third-agency documents for their use in requesting access to them from the originating agencies.

Under General Counsel guidance that we received from her Senior Advisor, substantive action on reference (d) was held in abeyance, although we made an inquiry of the Defense Central Index of Investigations (DCII) through the Defense Investigative Service (DIS) and informally passed a copy of the Committee's third request to Major Ed Whitehurst in the Army's Directorate of Security. We have not given copies to the Navy, Air Force, or DIA. Copies of the DCII results pertaining to the third request are attached for your use as you see fit.

With this remorandum we see no necessity for our further involvement in responding to House Select Committee on Assassination requests except as a privary source of any pertinent information we may have in our files.
