De la Vega Named to Region IV Group

Carlos de la Vega, director of Latin American relations at Ochsner Clinic, has been ap-pointed a member of the Region IV Advisory Committee to the Health Services and Mental Health Administration,

The appointment was made by the Secretary of the Department of Health, Education, and Welfare, Elliot Richardson.

A Cuban exile, de la Vega came to New Orleans in 1960 and was made a U.S. citizen last year. His governmental appointment is believed to be one of the highest received by a Cu-

ban refugee. In his new capacity, de la Vega will assist Dr. Gerald Barvega will assist br. Getatu Bar-ton, regional director of the health services agency, in ef-fecting programs in Louisiana, Arkansas, Oklahoma, Texas, and New Mexico.

The Health Services and Mental Health Administration is charged with federal hospital construction, collection of health statistics, providing grants-in-aid and other responsibilities.

The formation of regional ad-visory committees to federal agencies has been described as an effort by the administration of President Nixon to decentralize decision-making in programs at the cabinet level.

Region VI headquarters is in Dallas, Texas.
