SWANSON, SPECIAL AGENT IN CHARGE OF THE KNOXVILLE, TENNESSEE FBI OFFICE, THAT MISS PRESTUN HAD JUST READ IN A NEWSPAPER THAT GEORGE DEMORRENSCHILDT

HAD TAKEN HIS LIFE IN FLA., AND SINCE SHE HAS KNOWN DEMORRENSCHILDT AND HIS WIFE FOR MORE THAN 30 YEARS, SHE MAY BE ABLE TO FURNISH SOME INFORMATION OF VALUE TO THE FBI.

MISS PRESTUN, AGE 82, AND ADMITTEDLY SUMEWHAT FURGETFUL ABOUT DATES IN THE FAR PAST, STATED SHE WORKED AND RESIDED IN NEW YORK CITY FOR 50 YEARS PRIOR TO ABOUT 1960. IN THE LATE 1930'S, ONE OF HER NEIGHBORS IN NEW YORK CITY WAS JEANNE LEGONS WHO BECAME, AND HAS REMAINED, A FRIEND TO THIS DAY. SHE SAID LEGUNS WAS BURN IN CHINA TO A FRENCH MUTHER AND RUSSIAN FATHER. JUST PRIOR TO WORLD WAR II, LEGONS AND HER HUSBAND MOVED TO DALLAS, TEXAS. AFTER A SHORT TIME THEY WENT TO CALIFORNIA. STILL PRIOR TO WORLD WAR II, JEANNE LEGUNS ACCEPTED A JOB BACK IN DALLAS AND WENT THERE, LEAVING HER HUSBAND AND FAMILY IN CALIFORNIA. WHILE IN DALLAS, JEANNE MET GEORGE DEMOHRENSCHILDT. THEY HAD AN AFFAIR AND WERE LATER MARKIED. IN THE LATE 1930'S OR EARLY 1940'S, JEANNE AND GEORGE DEMORRENSCHILDT WENT TO EUROPE, SHE UN BUSINESS AND HE, ASSIGNED BY THE U. S. GUVERNMENT TO ASSIST YUGUSLAVIAN PRESIDENT TITU IN CONNECTION WITH OIL EXPLORATION. GEORGE AND JEANNE DEMONRENSCHILDT RETURNED TO THE UNITED STATES

ABOUT ONE YEAR LATER, LATE 1940'S OR EARLY 1950'S, AND THEY

VISITED MISS PRESTON EN ROUTE TO DALLAS, TEXAS. GEORGE

DEMORRENSCHILDT THEREAFTER ACCEPTED A JOB TO SURVEY FOR OIL IN

HAITI. HE AND JEANNE STAYED IN HAITI ABOUT ONE YEAR. THEY WERE

IN HAITI WHEN PRESIDENT JOHN F. KENNEDY WAS ASSASSINATED.

MISS PRESTON STATED IT WAS HER UNDERSTANDING THAT THE DEMORRENS CHILDTS CONTACTED THE FBI AFTER THEIR RETURN TO THE UNITED STATES A DOFFERED THEIR ASSISTANCE IN CONNECTION WITH THE KENNEDY ASSASSINATION.

MISS PRESTON STATED THE DEMONRENSCHILDTS MET LEE HARVEY
USWALD AND HIS WIFE MARINA THROUGH A LADY IN DALLAS, TEXAS, WHO
WAS ASSISTING MARINA IN OBTAINING DENTAL CARE TO REPAIR SEVERAL
BADLY DECAYED TEETH. SHE AND GEORGE HAD DESCRIBED LEE OSWALD
AS BEING A VERY BRIGHT INDIVIDUAL AND OF HAVING LEARNED THE RUSSIAN
LANGUAGE QUITE RAPIDLY. GEORGE DEMONRENSCHILDT NEVER SAID WHETHER
HE LIKED ON DISLIKED OSWALD. JEANNE DESCRIBED MARINA AS A
"NOTHING," A "WHORE." MISS PRESTON SAID SHE NEVER HAD ANY INFORMATION OR INDICATION THAT EITHER OF THE DEMONRENSCHILDTS HAD A
CLOSE OR SOCIAL RELATIONSHIP WITH EITHER OF THE OSWALDS. MISS

PRESTON SAID THE DEMONRENSCHILDTS VISITED HER IN TENN. IN THE MID 1960'S JUST AFTER THE WARREN COMMISSION REPORT ON THE KENNEDY ASSASSINATION HAD BEEN RELEASED. AT THAT TIME, BUTH STATED IT WAS THEIR OPINION THAT USWALD DID NOT ACT ALONE. THIS WAS EXPRESSED AS AN OPINION AND NOT STATED AS FACT BY THE DEMONRENSCHILDTS. MISS PRESTON DESCRIBED JEANNE DEMONET RENSCHILDT AS A GENTLE, WELL SPOKEN, COMPLETE LADY UNTIL ABOUT THE MID 1960'S WHEN SHE BECAME A VICTIM OF ALCOHOLISM. UNDER THE INFLUENCE OF ALCOHOL JEANNE WOULD BERATE GEORGE, STATING HE WAS STINGY, HAD A VIOLENT TEMPER, OFTEN STRUCK HER, AND THAT HE HAD HURT HER REPUTATION AMONG HER FRIENDS. JEANNE AND GEORGE DEMONRENSCHILDT CAME THROUGH TENN. IN ABOUT 1975. MISS PRESTON VISITED THEM AT A KNOXVILLE, TENN. MOTEL. AT THAT TIME, MRS. DEMONRENSCHILDT STATED SHE AND GEORGE WERE DIVORCED BUT CONTINUING TO LIVE TOGETHER.

MISS PRESTON STATED ON MAR. 19, 1977, SHE RECEIVED A
TELEPHONE CALL FROM MRS. GEORGE DEMOHRENSCHILDT FROM LOS
ANGELES, CALIFORNIA, TELEPHONE 213-363-6889, WHO INVITED HER
TO COME AND VISIT HER. AT THIS TIME, SHE WAS HYSTERICAL,

INAS CECICE KX 89-27 TALKED FAST, AND INDICATED SHE WAS LIVING UNDER THE NAME JEANNE LEGONS, SHE REMARKED "YOU DON'T KNOW WHAT I'VE BEEN THROUGH. ENGL GEURGE HAS GUNE CRAZY AND HAS BEEN IN THE HUSPITAL FOR TWO MUNTHS." SHE INDICATED HE HAD TRIED TO KILL HER, KNOCKED OUT THE WINDOWS IN THE APARTMENT, AND HAD TRIED TO COMMIT SUICIDE FOUR TIMES BY CUTTING HIS WRISTS AND TAKING DRUGS. SHE REMARKED TO MISS PRESTON "IT'S THE FAULT OF THAT HOLLANDER (DUTCH) NEWS REPORTER OLTMAN" AND INDICATED AT THAT TIME GEORGE DEMORRENSCHILDT WAS IN EUROPE
