RUSSELL, JR., ATTORNEY FOR THE DE MOHRENSCHILDS.

RUSSELL WAS INTERVIEWED AND A LEE HARVEY OSWALD PHOTOGRAPH WAS DISPLAYED ON TELEVISION. THE NEWSCASTER

ALSO REPORTED THE INSCRIPTIONS ON THE BACK OF THIS PHOTOGRAPH. RUSSELL ALSO DISPLAYED THE OUTSIDE WRAPPER OF THE CONTAINER HOUSING THE DE MOHRENSCHILDT'S MANUSCRIPT. RUSSELL MADE GENERAL COMMENTS AS TO HIS BELIEF THAT GEORGE DE MOHRENSCHILDT WAS NOT INVOLVED IN ANY ASSASSINATION PLOT.

~~MRS. JEANNE DE MOHRENSCHILDT~~ WAS ALSO PHOTOGRAPHED IN RUSSELL'S OFFICE BUT MADE NO STATEMENT. ^{Ca Tx} THE NEWSCASTER STATED SHE PROBABLY WOULD NOT BE AVAILABLE FOR INTERVIEW UNTIL NEXT WEEK.

A NEWS ARTICLE APPEARED IN THE DALLAS TIMES HERALD, APRIL 2, 1977, BEARING THE HEADLINE, "PHOTO AND MANUSCRIPT GIVEN TO INVESTIGATORS". THE ARTICLE WAS WRITTEN BY HOWARD SWINDE AND HUGH AYNESWORTH AND IN PART STATES, "THE PERSONAL EFFECTS OF GEORGE DE MOHRENSCHILDT WERE TURNED OVER FRIDAY IN DALLAS TO TWO INVESTIGATORS FOR THE HOUSE ASSASSINATIONS COMMITTEE.

INCLUDED WAS A PICTURE OF LEE HARVEY OSWALD TAKEN WITH THE MANLICHER-CARCANO RIFLE, LATER USED TO KILL PRESIDENT KENNEDY. UNDERNEATH IT, INSCRIBED IN RUSSIAN, WERE THE WORDS 'HUNTER FOR THE FASCIST, HA HA HA.'

THE EFFECTS HAD BEEN IN POSSESSION OF DE MOHRENSCHILDT'S
LAWYER, PAT S. RUSSELL, JR.

ALSO OF PRIME INTEREST IS A MANUSCRIPT, NEARLY 300 PAGES
IN LENGTH, ENTITLED, 'I'M A PATSY, I'M A PATSY' - WITH THE
THEME THAT OSWALD WAS A PATSY IN THE MURDER OF KENNEDY.
RUSSELL DID NOT COMMENT ON WHAT IS IN THE MANUSCRIPT BUT
SAID DE MOHRENSCHILDT HAD FINISHED IT ABOUT A YEAR AND A
HALF AGO.

ALSO TURNED OVER WERE TAPE RECORDINGS, PHOTOGRAPHS,
NEWSPAPER CLIPPINGS AND PICTURES OF A PERSONAL NATURE.

IT WAS LEARNED THAT THE INVESTIGATORS WHO IDENTIFIED
THEMSELVES FRIDAY NIGHT AS JONATHAN BLACKMER AND JOHN J.
MORIARTY, JR. WERE EN ROUTE TO PALM BEACH TO PICK UP
DE MOHRENSCHILDT'S POSSESSIONS BUT QUICKLY CHANGED THEIR
MINDS AND RUSHED TO DALLAS WHEN THEY LEARNED OF THE MANUSCRIPT."

ON APRIL 2, 1977, [REDACTED] WAS INTERVIEWED AND ADVISED ON APRIL 1, 1977 HOUSE COMMITTEE ASSASSINATION INVESTIGATORS SUBPOENAED ALL THE ITEMS HE HAD IN HIS POSSESSION CONCERNING [REDACTED]

[REDACTED] THE INVESTIGATORS ADVISED HIM THEY WOULD REVIEW ALL THE ITEMS AND RETURN THEM TO HIM WITHIN TEN DAYS. [REDACTED] STATED THAT IF THE FBI IS STILL INTERESTED IN REVIEWING THE ITEMS THEN TO CONTACT HIM.

ON THE MORNING OF APRIL 2, 1977, HE AND THE INVESTIGATORS WENT TO DE MOHRENSCHILDT'S APARTMENT AT BISHOP COLLEGE, DALLAS, TEXAS AND FOUND IT COMPLETELY STRIPPED OF ALL HIS PERSONAL BELONGINGS.

HE ADVISED THAT DE MOHRENSCHILDT'S 1977 GRAY FORD PINTO, TEXAS LICENSE PGC 61 IS STILL MISSING. [REDACTED] HAS INFORMATION TO BELIEVE THAT A FRIEND OF WILLEM OLTMAN'S, BY THE NAME OF DAVID RUSSELL, HOUSTON, TEXAS (ADDRESS UNKNOWN), MIGHT BE IN POSSESSION OF THE CAR. [REDACTED] REQUESTED HE BE ADVISED IF DE MOHRENSCHILDT'S CAR AND PERSONAL BELONGINGS ARE LOCATED BY THE BUREAU.

IT IS NOTED THAT BUREAU TELETYPE DATED MARCH 31, 1977
SET OUT LEADS TO LOCATE AND INTERVIEW DAVID RUSSELL IN
HOUSTON REGARDING DE MOHRENSCHILDT'S AUTOMOBILE.

[REDACTED] WAS ADVISED THAT HE HAS PERSONALLY
REVIEWED DE MOHRENSCHILDT'S MANUSCRIPT A COUPLE OF WEEKS
AGO AND ADVISED THAT THE MANUSCRIPT MAKES NO ALLEGATIONS
CONCERNING ANY FBI AGENTS BY NAME OR OTHERWISE AND NO
MENTION IS MADE THAT FBI AGENTS ARE INVOLVED IN ANY
CONSPIRACIES.
