Dear Mr. Epstein:

The letter dated September 20, 1977, with enclosure, which you addressed to the Honorable Frank M. Johnson, Jr., at our Headquarters has been received. Judge Johnson has not yet arrived in Washington to appear before the Senate Judiciary Committee for confirmation of his appointment as FBI Director. Thus, I am taking the liberty of responding to the letter which you wrote him.

The overwhelming majority of questions posed in your enclosure involve matters of apparent speculation on your part concerning sources and methods utilized by the FBI in its intelligence investigations, as well as identities of persons who may have been subjects of such investigations. Answers to questions of this nature could result in disclosure of sensitive classified national security information involving the foreign policy and national defense of the United States, and this is prohibited from disclosure by Executive Order 12652, as well as by a National Security Council Directive of May 17, 1972, and by Title 28, Code of Federal Regulations, Part 17 (28 CFR 17).

As is indicated in Volumes V and XI of the published "Hearings Before the President's Commission on the Assassination of President Kennedy," the April 10, 1963, shooting incident at the home of General Edwin A. Walker, in Dallas, Texas, was investigated by the Dallas Police Department, not by the FBI.
