Dear Mr. Forster,

Your letter arrived as I had left on the longest and most tiring of my investigative trips. I have just returned and am more than usually pressed for time, so this answer must be brief.

Dell seems to have ceased distribution of my books, not to be making any effort at all to sell them. We have no copies of and no access to that edition, hence my wife sent you the only available one of WHITWASH.

In the Tippit chapter of that you will find in more detail the answer to your question about the ballistics: there is no credible evidence here, certainly none that could have been used in court. The entire manner of official handling makes this even more suspect. I have not the slightest doubt that Oswald killed no one.

Your offer of help is appreciated. Unfortunately, the help we (and I) now need most is beyond the capacity of ordinary folk and those with means prefer not to associate themselves with what you so very well express in the second paragraph of your letter. I have two unpublished books ready for publication and dare not risk the added indebtedness. We have had no income and have reached the tolerable level in our indebtedness.
