#### Don't let it be 'circus,' Toman told

The Chicago Bar Assn.
Friday asked for a blue-ribbon
coroner's jury to investigate
the slaying of two Black
Panther Party leaders by
state's attorney's police.

The bar group even went so far as to suggest the partial makeup of such a jury.

Frank Greenberg, bar president, in a letter to Coroner Andrew J. Toman, cautioned Toman against letting the in-

quest into the two deaths become "a circus."

The bar's offer came as the Justice Department began a preliminary investigation into the Dec. 4 shootout to determine if the civil rights of Panthers had been violated.

Jerris Leonard, head of the civil rights division, said in Washington that Chicago FBI agents were making the investigation and estimated it would take about two weeks.

Leonard, interviewed by telephone, said that the Justice Department had received a substantial number of complaints and that he felt there was a need for the FBI investigation.

GREENBERG, acting for the bar's board of managers, offered the bar's help in selecting the blue-ribbon jury that Toman has said he plans to appoint.

The bar president proposed that Toman name two black attorneys as "friends of the

coroner" to question witnesses at the inquest and to give other legal assistance.

Greenberg, in a letter to Toman also pointed out that Toman was a physician, not a lawyer, and suggested he might want to appoint a lawyer as his special deputy to conduct the inquest.

AT A PRESS conference, Greenbergsuggested as possible members of the blue ribbon jury Joseph L. Block, retired chairman of Inland Steel Co.; Ben W. Heineman, board chairman of the Chicago & North Western Ry. and president of Northwest Industries; John Hope Franklin, chairman of the history department at the University of Chicago, and Edwin C. Berry, former executive director of the Chicago Urban League.

Greenberg said he felt an inquest by a blue ribon jury would "give vent to the pressure building up on both sides." He called for a halt in inflammatory statements on both sides.

The bar chairman said he planned to met with Toman and said that with the help of Mayor Richard J. Daley he was confident that Toman could recruit top jurors "for this terribly important civic venture."

Copies of Greenberg's letter were sent to Mayor Daley and State's Atty Edward V. Hanrahan. Toman has not set a date yet for the inquest.

HANRAHAN has challenged the seven Black Panthers who survived the Dec. 4 shootout to take lie detector tests.

Hanrahan said Thursday that if the Panthers agreed, he would then permit 14 state's attorney's policemen who took part in the raid on the

Panthers' West Side apartment to also take lie tests.

Bobby Rush, chief spokesman for the Panthers, said immediately after Hanrahan made his offer that he would be opposed to the Panthers taking lie tests.

However, Panther attorneys later indicated they were studying Hanrahan's offer.

SLAIN IN the Dec. 4 predawn raid on the Panthers' apartment at 2337 W. Monroe were Fred Hampton, 21, chairman of the Illinois Black Panther Party, and Mark Clark, 22, of Peoria, Downstate Panther leader.

Four other Panthers were wounded and three other Panthers in the apartment were arrested. One state's attorney's policeman was wounded and his partner was cut on the hand by flying glass.

FRANK J. McGarr, first assistant to Illinois Atty. Gen. William J. Scott, met Friday in Scott's office with a five-member delegation from Maywood, where Hampton grew up.

McGarr informed the group that Scott had called the Justice Department in Washington to ask for an investigation, A 20-member Maywood delegation had met

with McGarr Monday to ask for an investigation by the attorney general's office.

However, McGarr told them in the earlier meeting that the attorney general's office apparently lacked jurisdiction.

GREENBERG, in his letter to Coroner Toman, said, "We do join with all of the other civic organizations who have called for a full and complete investigation in the feeling that only by means of such an investigation can public confidence in our police and in the state's attorney's office be restored.

" . . . Only by an investigation, open to the press and participated in by representatives of the black community, can we hope to restore the public confidence which has been shaken by these events."

Concerning the blue-ribbon jury, Greenberg said: "However the jury is selected, it must consist of persons in whose fairness, integrity and openmindedness the whole community, black and white, can have implicit confidence."

#### Bullet holes are exposed as nailheads

"See those nailheads, The police said those are bullet holes," said the Black Panther Party guide to the throng of persons visiting the Panther apartment involved in the Dec.

The guide then showed one of four published photos that were released exclusively to the Chicago Tribune Wednesday night by State's Atty. Edward V. Hanrahan.

Officials in the state's attorney's office have since said that what the Tribune identified as bullet holes in the official photos were rusty nail-heads.

ANOTHER CIRCLE on the same photo indicated a purported bullet hole in a long curtain on the kitchen door. However, Daily News reporters could find no mark on the door or the wall to indicate that a bullet had passed through the sheet.

A bullet-riddled door that was identified in a Tribune photo caption as a bathroom pocked with bullet marks.

door is instead the door to the bedroom.


ANOTHER of the official photos, the property of Cook County, shows a hole in a door that leads to a front entryway from the living room of the apartment at 2337 W. Monroe.

The photos indicate the hole was made by a 12-gauge shotgun slug that passed through the door as it was fired at detectives, allegedly touching off the gun battle in which two Panther leaders were slain.

However, there is no hole in the walls of the entryway to indicate the bullet traveled on after passing through the door. The shotgun slug did not strike any policemen because none was wounded at the front door.

DURING TOURS, Panther guides pointed to the walls of the kitchen and dining area, indicating the walls have no bullet holes.

The guides contend that if the Panthers in two nearby bedrooms had returned police gun fire, these walls would be

#### Panthers

In these days of charges and countercharges and general confusion in the minds of many as to the facts and real stakes in the Black Panthers challenge to law enforcement and society in America in general, the "Black Panther Coloring Book" is most explicit.

Four drawings from this document and from the regular weekly Black Panther tabloid newspaper are reprinted today in The Daily Calumet. They are taken from hundreds of such cartoon-style drawings which appeared in the coloring book and appear in the tabloid newspaper each week.

They are worth many thousands of words in illustrating graphically the philosophy of this para-military organization which today has begun carrying out a program planned so well. The Black Panthers have begun their planned reign of terror, violence and hate in major U.S. cities, one of which is Chicago.

But the uninformed, as we are observing in Chicago in recent weeks have typically mis-read what is happening. They have not understood that the Black Panthers are a part of a much larger conspiracy to tear down, little by little, often subtly, periodically brashly the American system of government. This tatoo of subversion has been so cleverly carried out that the real danger is that the true issues are clouded.

The reproduction of the Black

Panther drawings in The Daily Calumet today is an effort to un-cloud the situation – to open it up to the sharp focus of daylight.

On the subject of Black Panther written materials sold openly and at considerable profit throughout Chicago as well as other cities across the country, the National Education Program magazine in a special edition said recently:

"The Black Panther weekly newspaper, which now is approaching a circulation of 100,000, is an undisguised instrument of hate — hate against the 'fascist police pigs,' hate against the white race (except those elements that have joined with the Panthers in their revolutionary goals), hate for the American system. The Panthers, well armed and apparently well-financed, parade themselves with loud bravado in more and more Negro communities as a band of swashbuckling Robin Hoods who intend to take 'with whatever means are necessary' all the

things that they say the Negroes should have . . .dominate power, the wealth of America . . .the institutions.

"One of their attractive propaganda devices in recent months has been the 'Free Breakfast Program.' In dozens of cities from coast to coast they have rounded up a few Negro children of grade school age, and with great fanfare have fed them breakfast in a church or some other available building. With propaganda photographs and news 'releases,' and in the 'New Left' press throughout the country, they have made this appear to be a nation-wide project which soon will 'reach every hungry Negro child' in the nation."

The NEP magazine continued: "San Francisco police inspector Ben Lashkoff, in voluminous testimony, back with unassailable documentation, told the U.S. Senate's McClellan Investigation Committee that one such breakfast was being held in the Sacred Heart Church (Catholic) in San Francisco; that instead of the 'hundreds' of children fed, as loudly claimed by the Black Panthers, there were no more than 20 attending the daily breakfast, and that the affair was used as a device to engender in the children, and ultimately their families, hatred against the police, the white race and the American system."

Dr. George Benson, author of the article in the National Education Program magazine, wrote: "On my desk as this is written is a copy of the Black Panther 'coloring book' which Inspector Lashkoff introduced as documentary evidence showing the vicious nature of the Black Panthers and their allies. He said it was handed out to children attending the breakfast in the Sacred Heart Church – and with the knowledge of church authorities.

"It teaches young Negroes to kill"

in the hands of children.' It declares:
'Power comes through the barrel of a

"The Black Panther Party has sought to 'disown' the Black Panther 'coloring book' since the nation-wide publicity it received after its dramatic exposure at the Senate's McClellan Committee hearings. The Black Panthers cannot get away with disowning it.

"It is their creation. They distributed it. It carries the message of the Black Panthers just as it is being carried each week in their widely distributed newspaper, the Black Panther. The same cartoonist (signed: 'Teemer') who drew the 'coloring book' cartoons

showing children stabbing and shooting policemen, continues to draw the same cartoons in every issue of the Black Panther newspaper.

"It is a massive dagger-like weapon aimed at the heart of police and all other governmental authority. The

'coloring book' is an incitation to Negro children to murder whites."

Following is an excerpt from the report of J. Edgar Hoover, director of the Federal Bureau of Investigation, to Congress, April 17, 1969:

"The political philosophy of the Black Panther Party is based in part on the writings of Mao Tse-tung of Communist China. It advocates that its members study the teachings of Mao Tse-tung. Instructions have been given to members on the making and use of Molotov cocktails. Members have also been instructed in guerrilla welfare tactics in preparation for a showdown with established authority. It is reported that in the near future scheduled training sessions in California will teach guerrilla warfare tactics to selected members from all parts of the United States."

San Francisco Chronicle reporter Ed Montgomery recently completed an assignment as an undercover agent gathering material on the Black Panthers. During his tour he wrote later he heard firebrand revolutionaries instructing their comrades in a "Code of Treason," to accomplish the overthrow of duly established government in this country. The "Code" reads:

—Don't fight the draft. Go to Viet Nam and shoot your commanding officer in the back.

-Become an airplane mechanic and learn to sabotage planes.


-The Army can be won over from within. The police and the leaders of the establishment are our prime objectives.

-All police and members of their families must be killed and law enforcement demoralized.

 All jails and prisons must be opened and inmates liberated.

--All counter-revolutionaries, or imperialists, who would fight "liberation" must be cut down.




