THE ONLY INVESTIGATION CONDUCTED AT PARKLAND HOSPITAL IN CONNECTION WITH THE MEDICAL TREATMENT PERFORMED ON THE LATE PRESIDENT IS REFLECTED ON PAGES EIGHT THROUGH TEN OF REPORT OF SA ROBERT P. GEMBERLING DATED NOVEMBER THIRTY, SIXTYTHREE, WHEREIN THERE IS SET FORTH VERBATIM A SUMMARY OF THE TREATMENT PERFORMED UPON THE PRESIDENT PREPARED BY DR. KEMP CLARK, DIRECTOR, SERVICE OF NEUROLOGICAL SURGERY, PARKLAND MEMORIAL HOSPITAL. THIS REPORT WAS PREPARED AT THE REQUEST OF DR. GEORGE G. BURKLEY AND WAS TRANSMITTED TO DR. BURKLEY BY LETTER DATED NOVEMBER TWENTYTHREE LAST. IT IS NOTED THAT IMMEDIATELY AFTER THE PRESIDENT WAS PRONOUNCED DEAD, HIS BODY WAS PREPARED FOR IMMEDIATE SHIPMENT TO WASHINGTON, D. C.
