Re Bureau letter dated 10/19/66 to Mr. WESLEY J. LIEBELER, enclosing copy of letter to Bureau from Mr. LIEBELER dated 10/14/66, wherein he requested assistance in obtaining information for a book he is writing, describing generally how the President's Commission on the assassination of President KENNEDY conducted its investigation.

Enclosed for the Bureau is one Xerox copy of a letter from Mr. WESLEY G. LIEBELER to Mr. CHARLES KLIHR, 2046 Rosebud, Irving, Texas, dated 10/12/66 which letter is self explanatory. Mr. LIEBELER's letter was furnished the Dallas Office by a letter from Mr. KLIHR, reflecting his address as 1703 Salem, Irving, Texas. Mr. KLIHR advised that he had no intention of answering the letter because Mr. LIEBELER did not give a suitable reason for his inquiry. Mr. KLIHR stated in his letter that the enclosure of the photograph mentioned in Mr. LIEBELER's letter was not received by him.

For the Bureau's information, investigation concerning the 1957 Chevrolet mentioned by Mr. LIEBELER is reflected on page 263 of the report of SA ROBERT P. GEMBERLING dated 5/28/64 at Dallas, Texas, and in the report of SA GEMBERLING dated 7/2/64, on page 104, both captioned "LEE HARVEY OSWALD, aka., etc." Dallas file does not reflect KLIHR was interviewed during this investigation.

The Dallas Office is in complete agreement that no information whatsoever should be given to Mr. LIEBELER and questions the possession by Mr. LIEBELER of copies of exhibits indicated in his letter to Mr. KLIHR. No investigation being conducted, UACB.

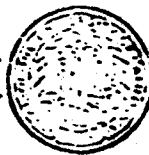

Dear Mr. Klihr:

I am a former assistant counsel to the President's Commission on the Assassination of President Kennedy. My interest in some aspects of the events of November 22, 1963 has been rearoused by some of the books that have been recently published about the Commission and its Report.

One of the pictures that Oswald took of the area around General Walker's house showed a car parked behind the General's house. The picture was mutilated by someone in such a manner that the license plate is no longer visible. When we noticed this during the investigation we asked the FBI to determine whose car it was. They asked Mr. Surrey about it and he told them he thought it was your car. I find no indication that FBI agents talked to you about the matter, however.

When I asked General Walker about it, he was not able to identify the car, which appears to be a 1957 Chevrolet.

I would appreciate it very much if you would let me know whether or not the FBI did interview you about this and if you were able to identify the car as your own. I enclose a copy of the exhibit in question so that you can determine now whether it is your car or not, if the FBI did not interview you about it.

As this matter is of some importance to me, I hope very much that you will be able to extend your cooperation.
