SUBJECT: LEE HARVEY OSWALD, aka.

On March 31, 1964, JOHN MARTIN, JR., Superintendent of Safety, Room 517, U. S. Post Office Terminal Annex, 207 South Houston Street, Dallas, telephone number RI 9-3181, who resides at 9846 Shoreview Road, Dallas, Texas, telephone DI 8-3546, furnished information concerning the organization of a corporation called Dallas Cinema Associates Corporation, P. O. Box 15521, Dallas, Texas.

Mr. MARTIN advised that following the assassination of President KENNEDY, WYMAN PARR, 4448 South Marsalis, conceived the idea of contacting others like himself who had taken movies of the Presidential motorcade. He stated PARR got in touch with RUDY BRENK, 4404 Ivy Street, Dallas, and BRYANT BOREN, 605 West Vista Drive, Garland, Texas, and that these three individuals contacted other individuals, who will be listed hereinafter, and were able to compose a film about 180 to 200 feet in length covering the Presidential motorcade from the time the President arrived at Dallas, Texas, until the Presidential motorcade turned west off Houston Street onto Elm Street. MARTIN, who stated he took 25 feet of film which was included in this movie, stated his film was the only film taken in the immediate area of the Texas School Book Depository Building, and that the film he took does not show the assassination or any view of the Texas School Book Depository Building above the second floor. Mr. MARTIN stated that other individuals, listed hereinafter, took movies of the Presidential motorcade at various points along the parade route and that on March 18, 1964, the above-named corporation was formed.

MARTIN indicated that he believed the film is presently in the custody of RUDY BRENK, who is the president

of the corporation, and that present plans were to have this film reproduced by Technicolor and stated he believes that Technicolor is located in Rochester, New York. MARTIN further stated that he believed that Sanger-Harris Department Store, Dallas, was going to have exclusive rights for a period of three months to sell this film. He stated he did not know when the sale of the film would commence.

By Bureau airtel to Dallas 4/6/64, the Bureau instructed that it was essential that all of the above-named individuals, if not already interviewed, be interviewed, particularly for any knowledge whatsoever they may have regarding the assassination of President KENNEDY. The Bureau pointed out that any of these individuals who allegedly took photographs of the Presidential motorcade are logical individuals for interview.

The Bureau further directed that every effort be made to review the film of this corporation to determine if it has any pertinence to the inquiry being conducted by the President's Commission and, if so, an appropriate copy obtained and submitted to the Bureau for review and possible dissemination to the Commission.

Agents PETRAKIS and SWITZER are being assigned this project to interview all of the individuals listed above, with the exception of MARTIN, who was previously interviewed by these agents. The results of each interview are to be submitted on an appropriate FD-302 for the 100 case with one flimsy copy. It is suggested that the film or a copy be obtained for review and submission to the Bureau.

This should receive expeditious attention.
