## AFFIDAVIT

I, CLIFFORD H. ANDERSON, being duly sworn, depose and say as follows:

(1) I am a Special Agent of the Federal Bureau of Investigation (FBI), assigned to the New Orleans Field Office of the FBI at New Orleans, Louisiana. My responsibilities as a Special Agent include the handling of Freedom of Information Act (FOIA) matters within the New Orleans Field Office.

(2) Pursuant to the request of FBI Headquarters (FBIHQ), received on August 10, 1977, I caused a search to be made of the General Indices of the New Orleans Field Office, on August 10, 1977, for all records and exhibits pertaining to the assassination of Dr. Martin Luther King, Jr., and filed ider the FBI designated title for that investigation "MURKIN." the method of search conducted was the same as that utilized to retrieve records necessary to fulfill the FBI's investigative responsibilities.

(3) Thereafter I supervised the review of those records and exhibits located pursuant to the search described in Paragraph (2) above and, on August 29, 1977, forwarded one copy each of said records and exhibits containing documents to FBIHQ, with the exception of those records previously directed or received from FBIHQ or the Memphis Field Office of the FBI which did not contain a substantive notation thereon. Those exhibits which contained items other than documents were not copied or forwarded to FBIHQ, however are listed below:
