Mention of the film was also made in the Administrative page of that report.

By airtel to Pertland dated 1/31/64 the Eureau returned the above film to Pertland with the comment that the Eureau had no further need for this film, and that the film was enclosed for return to J. PAT DOYLE.

The film was returned to DOYLE on 3/10/64.
