This kind of rewriting of my requests has led to much costly litigation.

And, of course, non-compliance, the clear purpose. The Assassination of Ident John F. Kennedy

I've heard many complaints about the FBI but that it is unable to read English is not among them. This letter is to acknowledge receipt of your letter to the New York Office, dated July 16, 1979.
