While,going over records for Theoharis this afternoon I noticed that although ultimately serialized in 89-43 a Jim Bishop record was originally designated for 80-879 by the SAC.

In fact, both of the original copies are designated for two different 80 files, the second appearing to be 943. Another in this series of Bishop records, of which I believe I provided copies to you, hus a note on it to make a new 80 file.

Now according to the ^Central File publication, the field offices do not us NR copies, but here, clearly, they have a similar system. Moreover, the serialized copy, if it is the only such as the FBI's publication represents, is in an incomplete file. The added note states that the list Bishop submitted is in the 80 file.

While I now do not have any clear recollection of it, I believe I went into the field office use of this ""aboratory "esearch Matters" file classification for other and entirely unrelated matters, include what can be regarded by the FBI as delicate.

I know I identified relevant New Orleans 80 files, without response, and now we have proof that Dallas 80 files are relevant and undearched.

Whatever else the field offices use 80 for, it is apparent that they use it for press contacts and that is why after my request they destroyed all those JFK 80 records in N.O. This is in the case record.

On Nov. 22, 1967, Mr. BISHOP and his wife came back to the office and stated they had been having quite a bit of success with everyone they had contacted with the exception of a start and the second the Dallas Police Department, who had told them they would not give them anything. Mr. BISHOP was furnished information concerning the evidence he requested, which was in pages 159, 160 and 161 of the report of SA ROBERT P. GEMBERLING dated 11/30/63 at Dallas, Texas, captioned "LEE HARVEY OSWALD, aka; ASSASSINATION OF PRESIDENT JOHN FITZGERALD KENNEDY, NOV. 22, The only other information which I furnished was: He 1963." wanted to know how I learned that President KENNEDY was shot, and I told him that I had an employee monitoring the police / radio. He wanted to know then what X did with the information, and I 'told him I immediately furnished it to Mr. HOOVER. "I also told him that upon receipt of information concerning KENNEDY's death being definitely determined, I furnished this information to Mr. HOOVER.

189. It is noted he stated that this book would be ibmitted to Assistant Director DE LOACH prior to publication On the morning of 11/24/67, BISHOP called and stateded
