Robert Oswald paid \$700.- for expenses of travel from New York to Dallas for Oswald and family according to records of the Department of Health, Education & Welfare. (WFO teletype 11-17-63)

No record was found of a checking, savings, or loan account or safe deposit box in banks in the New Orleans area in the name of Lee Harvey Oswald. Similarly, no record was found at the Louisiana Department of Revenue, Income Tax Division, Louisiana Driver's License Division, Louisiana Motor Vehicle Division, or New Orleans Sanitation Department.

Oswald received take home pay of \$548.41 for employment 5-10-63 through 7-19-63.

Texas Employment Commission paid \$363.- in unemployment compensation to Oswald during the balance of the period Oswald was in New Orleans, La. through the Louisiana Division of Employment security.

The Texas Employment Commission paid Oswald \$6⁰⁰ after his return to Dallas, Texas.

Total income in New Orleans \$911.41
Rent paid by Oswald in N.O. 260.-
He skipped owing two (2) weeks rent.

The last^{4th} employment compensation check, \$33.00 dated 9-23-63 was cashed at a grocery store in New Orleans and

received at National Bank of Commerce,
N.O. on a date appearing to be 9-29-63
but this date is not completely legible.

Oswald employed 10-16-63 to 11-22-63 by Texas Schoolbook Depository, Dallas, Texas. Oswald was paid \$104.41 on October 31, 1963, and a similar amount on November 15, 1963. Total paid him was \$208.82. Sum of \$43.37 currently owed him for work performed. He was paid biweekly.

(Moore to Sullivan memo 11-27-63)

Mrs. Marina Oswald in interview on 11-28-63 stated Oswald employed New Orleans from May until latter part of August at \$1.35 or 1.50/hour. Then he collected \$33.00/week unemployment check for remainder of period in New Orleans. She states, to her knowledge, Oswald had no other source of income or availability to funds other than his employment and later the unemployment funds. He had no

bank account, no safe deposit box, and kept savings accumulated from earnings or unemployment checks in wallet at home. Savings amount was small

Former [REDACTED] on reinterview 11-18-63, advised that John Ross, Chairman, Fair Play for Cuba Committee, sent money to Harvey Lee Oswald, that Ross knew Oswald, and that money had been sent periodically over a period of the past five (5) months. Informant states he heard this information from [REDACTED]

[REDACTED] Informant stated he was confused and uncertain as to who participated in conversation. Interviewing agents also advised informant appeared completely confused.
