Dear Alan,

I delayed sending you the enclosed in the hope I'd receive wire-service stories and news clippings based on my release of new evidence from FBI files on the ring assessmation. My usual sources have not supplied the wire copy, I saw only one story, in the Washington Post (and have mislaid it!), and the first of a series of what I expect to be new whitewashes will be aired before you can receive this. I expect more of the same is possible from the Times, which has thrice delayed a series that has taken much of my time.

However, you may want to make some effort based on this new king attention. So, I'm sending you with this a batch of clippings the headlines of which may serve your purposes if you do. In addition, I am in court on this (C.A.75-1996) and expect more than I've released. When the papers gave what I gave away no attention, despite heavy radio coverage and CRS-TV news coverage, I decided to try to make an effort to sell a story based on it. I've made saveral approaches. Otherwise I'd send you copies of the copies of the FBI's files.

There has always been less interest in the King assessination, <u>marticularly</u> among blacks. Although I wrote the only book opposing the official version I've never been asked to make a speech on it. Aside from whatever psychological factors may underlie this, there is the endless insanity typified by what Dick Gregory is doing, now joined by abernathy. All that splif is worse than garbage. He is creasy.

This now seems to be changing. By pressu conference was sponsored by a black Congressman with whom I'm to have more meetings after the recess. I am also working with a black reporter, who has made a proposal to his newspaper, which has a syndicate.

It is possible that the whitewashes I expect may turn black compuses on. I have no way of knowing so I can't encourage you to spend roney on a King flyer. I do suggest, thought, that including one with the JFK material might generat some interest on white campuses. I have plenty of visuals but see no need to make slides until there is a need.

Speaking of slides, please let me know promptly the kind of trgy to get to carry the JFK slides in. I would like them to be in place for the Waynesboro program.

And speaking of that, please let me know the arrangements as soon as possible. While I can walk more and more easily if a student wants to go with me I'll have to make the arrangements. Eure helped with Belin! Whether or not one does, I'll still want to arrange transportation to National Airport. I drove to Washington two weeks ago and it was too much. I can't keep my legs pendant that long. That and the need for more rest are the only immediate problems. I have done a number of talk shows that lasted for hours and several into the wee hours, by phone. I've also met the obligations I told you I had to speak without fee at Maryland and Georgetown with no problems.

Back to king and the unpredictable: the Washington Fest reporter who wrote the story I've lost has turned on. I don't know which way he'll go and generally the Post has been virulently prejudiced against assassination stories. (I can replace that clipping if I do not find it as, gradually, I catch up on 10 weeks of accumulated stacks that have to be filed. I can bend for only so long at a time. Circulation in legs.) The last I hard from his he was to go to Atlanta this coming week and spend it with..... King's family and associates, after which he was coming here.

Do you represent David Slawson? I've written him to ask him to debate me where he is professor of law, at U.S.C., Los Angeles. I've told him that as long as I can sit with my legs up and he has it arranged through you he can arrange any format he wants.

I thought I asked you about Arlen Specter. If I did not let me go over it.

Post Mortem really focuses on his work. Destructively of him and his integrity.

However, we've had no orders from any "hiladelphia book store. So, having no copies

of any Philadelphia newspaper clippings and knowing that the story was suppressed in all major cities despite the fact that all four radio nets gave it good play I think he may not know the content. He is familiar with my marlier work, which he has yet to deny. He has, in the past, declined perhaps two dozen invitations to confront me, when he was DA in Philadelphia.

The day he announced his candidacy is the Republican nomination for Senator from Pennsylvania he was asked, on tape, by a radio reporter, if he would debate me. He then said he would. I asked the reporter who told me to ask him to make any arrange-

ments he preferred, my preference being any law school. Since them silence.

What I would like you to do is write him at his Phila. law of ice reminding him of this and asking if he is willing to debate me in his city. If you have any customers there you might want to ask them first and then tell him, if you get it, that you have this agreement. Please, if you do this, indicate on the original that you have sent me a carbon. If he does not answer within a reasonable time or if he refuses I'll be able to use it.

I'll agree to any format he wants as long as it pracludes long lawyers' speeches. What I did with Belin is an exception and it accomplished my purposes. I won't prepare a speech and I'd prafer that neither of us make a long one.
