This teletype reports what was told the Dallas Field Office by Engene P. Aldredge, his observation of themark left by a bullet that hit the sidewalk where the point of allegel/y origin could not possibly have been where Oswald was.

I have appealed the withholding of other relevant records.

A note was added to this HQ record directing a copy to the tickler.

The tickler has not been provided.

I appeal the withholding.

The concluding sentence is relevant to my prior appeal. It reflects that no further investigation would be conducted unless directed. Further investigation was conducted.

I do not recall seeing any copy of any directive for any further investigation yet twice thereafter Dallas sent samples to the Lab in Washington for testing, the results of which I also have not seen.

ON SEPTEMBER TWENTYNINE INSTANT, EUGENE PALDREDGE, NINE THREE ZERO FOUR LENEL, DALLAS, TEXAS, TELEPHONICALLY CONTACTED THE DALLAS OFFICE STATING HE DISAGREED WITH PRESIDENT COMMISSION'S REPORT THAT OSVALD DID NOT HAVE HELP IN ASSASSINATION.

DEPOSITORY BUILDING.
