

Dear Mr. Weisberg:

In connection with your Freedom of Information Act request directed to the Central Intelligence Agency concerning Warren Commission documents, the CIA surfaced fourteen (14) documents which originated with USIA. These documents, consisting of seventy-two (72) pages of material, have been reviewed by this Agency and determined that they can be released.

According to USIA rules for processing requests under the Act, duplication fees for the material at the rate of \$0.15 per page would total \$10.80. Upon receipt of payment for duplication fees, payable to the Treasurer of the United States, copies of the aforementioned documents will be sent to you.
