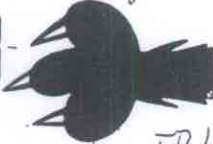

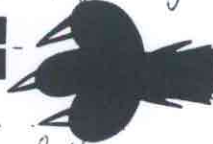

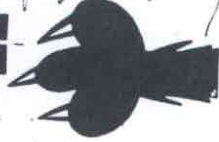

used of those 40,000 pages



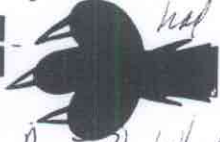
