Today I received from Jim "oscar, to whom a carbon, several more excerpts from the FBI JFK assassination ticklers, disclosed 4/25/85, to Mark Allen. A couple may be of interest to you.

In the Marguerite Oswald tickler, Documents 32 and 33, reflect FBIHQ directives to Dallas to establish a separate Marguerite Oswald file. It thus did not require any discovery from me to locate this file and no discovery from me could have enabled it to prove that it had complied. Now Evidence, I'm pretty sure the second of this nature subsequent to the case going up on appeal.

I enclose one page only of Document 1 from the Marina Oswald tickler, page 6. It recounts how the alleged assassin was so intent upon making his place in history he almost overslept his rendezvous with destiny.

The Marina Oswald Tech. Surv. tickler holds the news account of an FBI statement after its electronic surveillances on her were disclosed. I include it to give you an illustration of how the FBI lies without seeming to lie. Its own statement is that it "had conducted apart electronic surveillance on Marina Oswald's residence from Feb. 29, 1964 to March 12, 1964, based upon written approval of the attorney general of the United States." The FBI did not seek or get approval for bugging her house before she moved in. It did get approval for the wiretapping only. Its reference to those surveillances is in the singular.

RE: MARGUERITE CLAVERIE OSWALD

The above information is being furnished for the information of each of the recipient offices. Bureau does not desire that any investigation be conducted concerning subject in connection with her contemplated trip to Russia. Any information coming to the attention of any of the offices bearing on subject's trip to Russia or any other aspect of the assassination of the late President John F. Kennedy as it involves subject should be promptly furnished to the Bureau in a form suitable for dissemination.

NOTE:

Subject has exhibited behavior since the assassination that she is emotionally unstable. She is telling any one who will listen to her that her son was not the assassin or was not involved alone in the assassination. She has contacted our FBI Office in Dallas on a number of occasions to furnish information she feels is of value. We are accepting information she furnishes but are conducting no investigation of her. For filing purposes and for ready reference in the future, desirable we maintain a separate file on subject. Heretofore information concerning her has been filed in the main case file of Lee Harvey Oswald.

Relet instructed that any information coming to the attention of any of the offices receiving relet (Dallas, WFO, New York and New Orleans) bearing on subject's trip to Russia, or any other aspects of the assassination of the late President JOHN F. KENNEDY, as it involves subject, be promptly furnished the Bureau in a form suitable for dissemination.

The Bureau's attention is called to the fact that subject is mentioned frequently in the news media in connection with her allegations that her son, LEE HARVEY OSWALD, was innocent, duped, ^{involved} in a mercy killing of the President by the U. S. Secret Service, and other absurd statements.

UACB, such newspaper articles will not be included in LHM but will be furnished the Bureau by routing slip, attention Crime Records, as has been the practice in connection with newspaper clippings bearing on the assassination in the past, and copies of such newspaper articles will be filed in the Dallas Office.

Once when Mrs. Paine was having a birthday party for one of her children, and the other when Oswald went looking for another job.

On Thursday, November 21, 1963, Oswald appeared unannounced at the Paine residence, at about 5:45 p.m., and asked to see Marina. He stated that he was lonesome. Oswald played with the children and watched television, then about 8:30 p.m. he went to bed.

On the morning of November 22, 1963, Marina said she awoke at 6:40 a.m. and began to feed the baby. At around 7 o'clock Marina awoke Oswald and told him he had better get up or he would be late for work. As he dressed he told Marina that he would fix his own breakfast. Marina does not believe that he did this, as she found the coffee pot to be cold when she went into the kitchen about 7:20. Marina advised that she does not know of anything that Oswald took with him from the Paine house to work on November 22, 1963.

Marina and Mrs. Paine were looking at the motorcade on television when it was announced that the President had been shot, and that the shots had supposedly come from the Texas School Book Depository building. A thought immediately entered Marina's mind: "Did my crazy one do it?"

FBI Didn't Report Oswald Wife Tap

The FBI tapped the tele- phones and bugged the liv- ing quarters used by Mari- na Oswald after the assas- sination of President Kennedy, but it failed to re- port either the fact of the surveillance or its product to investigators for the Warren Commission, ac- cording to a former FBI official.

The offi- cial, who was closely involved with the investigation conducted by the Bureau in the wake of the assassination, said that the electronic surveillance was instituted on the Russian-born Mrs. Oswald shortly after her husband, Lee Harvey Oswald, was identified as the principal suspect in Kennedy's mur- der.

The surveillance, the for- mer official said, continued for "some months" after the death of Kennedy on Nov. 22, 1963, and the kill- ing of Oswald himself two days later by Joe's Ruby, a Dallas nightclub operator.

BUT HE SAID that, to the best of his recollection, the surveillance never pro- duced information that bore directly on Oswald's mo- tives or supported suspi- cions held by some FBI officials that he had been involved in a conspiracy against the president's life. It was those suspicions, the former official said, that prompted the bureau to initiate its electronic "coverage" of Mrs. Os- wald.

The FBI said in a state- ment yesterday afternoon that the agency had "con- ducted an electronic sur- veillance of Marina Os- wald's residence from Feb. 29, 1964, to March 12, 1964, bas- ed upon written approv- al of the attorney general of the United States."

At the time, the govern- ment contended that in "national security" cases court permission was not required.

~~THE FBI did not deal~~ with its reported failure to inform the Warren Com- mission of the eavesdrop- ping effort.

None of the volumes of testimony or evidence pub- lished by the Warren Com- mission contain any hint that commission lawyers were told by the FBI of its surveillance of Mrs. Os- wald.

Key commission counsel and investigators confirm- ed that they could not remember having been told that her conversations had been monitored.

David W. Belin, a Des Moines lawyer who was an assistant counsel to the commission, said that if this account was accurate, "it strikes me as horrible" that the commission was left uninformed.

HIS SENTIMENTS were shared by Albert E. Jenner Jr., also a former assistant

commission counsel and now a Chicago lawyer, who said that whether the sur- veillance of Mrs. Oswald had come out "positive or negative," the panel should have been allowed to weigh whatever information was gleaned.

The commission, named for Earl Warren, the late chief justice who acted as its chairman, was set up by former President Lyndon B. Johnson within a week of Kennedy's death, with in- structions to determine the circumstances that sur- rounded the assassination.
