KEMMEDY facing the driver with back to wis. Jemmy. Governor CONMALIT wa's seated on "jump seat" on right side of the car in front of the President with back to him

The cir was going in west or southwest direction in downtown Dallas, Texas, November 22, 1963, when the following indident occurred:

Governor CONHALLY stated, "First sense or realization of anything unusual I became conscious of $a$ shot or with sounded Like a gun shot, I knew it came Pron ny right rear. I instinctively turned to my right to Book back, and as I did so I sensed more than I saw, that President KEMEDY vas hit.
"As I turned ${ }_{2}$ I realized something wats amiss with President Kerned and teen I turned backs to ny left a little and as I did so $I$ got hit with a bullet in my right shoulder just below tie shoulder blade and arm pit about four inches from my right side. Tais bullet pierced ry y chest coming out the right side of my chest
 about the wrist, passed through and then lodged in by left inner leg just above the knee where the bullet, apparently split. I believe I remarked, : On my God. Thay:are going to kill us all.
"Realizing I had been hit I crumpled over towards

"I was conscious of a taird shot and heard it. I hag a feeling the third shot hit President KEMMEDY but did not see it actually strike his body. I was conscious Of the fact that the third shot had iot bit NELIIE, "口y wife. About this time I became conscious of tha Iact we vere all splattered with what I thought was brain tissue frou President KEmEDY.
"The Secret Service man in front of me bad turned to Iook back and also the diriver. Tha Secret Service aan in front of me remarlsed; 'Let's get out of here, ' and I recall the Secret Service man talling ou the radio in the car to the effect 'Get to 2 hospital quick.'
"I was conscious of the car サheeling out of Iine of the caravan and rapidiy picking up speed and then I was unconscious until the car began stopping at the hospital when I regnined consciousness and realized I must get out of the way so Prosident KEMEDY could be removed. froz the $c a r$, and I made some moverent trying to get out of the car.
"I recall boins carried on a stretcher into the hospital and xomarking, "Oh my God, it hurts, it hurts.' I also rocall after houring the third shot lirs. Femitedy said, "Oh my God, ihoy Lave shot my husband, JACK, JACK."

Winen Goyernor CONinatuy was asked about the elapsed time between the first and last shot he remarlsed, "Fast, my Coll, it was fast. It seemed like a split second." ,
"Just that quick," and he saapped his fingers three times rapidly to illustrate the time and said, "unbelievably quičs."

He saw no flash from a gun and did not see a gun. He stated he was not conscious of anything tant yent. on outside the car itself.

Governor CONNAT,TY added, "Yy impression at the moment..it happened was I baci been bit by a stray bullet.".
"In retrospect I feユt the assassin had intended to hit me, but, do not now honestly feel he intended to mit me." Governo: CONNAMLY telt tha shots wero fired so Past the assassin had hit hia by accident on the second sirot. He never heard President KinNEDY utter or say $a$ vord after the first shot.

His inpression was that apter the third sinot President KMNPDV Lad probably been satally wounded.
