TURNER, RICHARD SPRAGUE, A COMPUTER AND PHOTOGRAPHIC EXPERT,
FLETCHER PROUTY, A FORMER W.S. AIR FORCE INTELLIGENCE
CFFICER, AND WRITE'S FIRME OF MY AND PARIS FLAMMONDE.

FEMSTERMALD IS A FORMER AIDE TO THE LATE SENATORS ESTES KEFAUVER AND HOMAS HUMINOS AND WAS A COUNSEL TO FORMER SENATOR EDWARD LONG'S COUNTIES ON THE INVASION OF PRIVACY.

IRONICALLY, IT WAS A LEAK OF INFORMATION BY THE INTERMAL REVIEWE THAT SMEARED SEMATOR LONG'S COMMITTEE BY GIVING

THIS BOOK HAS STILL NOT DEEN REFUTED AND IS ONE OF THE MAIN MASONS WHY THE OVERWHELMING MAJORITY OF AMERICANS BELIEVED HENNEDY WAS KILLED BY CONSPINATORS.

THE POLICE CHIEF WAS SO ALARHED HE OPDERED PRESIDENT KENNEDY'S MANI MOTCHGADE TO BE CANCELLED AND NOTIFIED THE FOI AND THE SECRET SERVICE OF THE REASONS - KYET NO MENTION OF THIS CAN BE FOUND IN THE WARREN COMMISSION'S REPORT.

THE COMMITTEE TO INVESTIGATE ASSASSINATIONS HAS SHIPPETS OF DIFFERENCE CHARACTERS TO TITILLATE AND UNET THE APPETITE OF ANY ASSASSINATION DUFF, BUT INCREDIBLY THERE HAS STILL DEEN NO OFFICIAL REACTION.

THE DOUBTS EXPRESSED BY FORMER DALLAS POLICE CHIEF JESSE CURRY, WHO WAS IN CHARGE OF THE DALLAS POLICE AT THE TIME OF THE ASSASSINATION, ARE PERMAPS THE MOST INTERESTING OF ALL.

IN HIS DOOR, "JUK ASSASSANATION FILE," CURRY CLAIMED THAT A FAMAPPIN TEST OF THE RECET SIDE OF OSUALD'S FACE SHOWED NO TRACES OF ANY NITRAYES, UNION USUALD HAVE EXPECTED IF OSWALD HAD FINED A RIFLE.

HE ALSO SAID THAT HOUMED DREAMAN, THE STAR WITHESS WHO IDENTIFIED COMMIND FOR THE WARREN COMMISSION AND TESTIFIED THAT HE HAD SEED HER FIRMS FROM THE SINTH FLOOR OF THE BOOK DEPOSITORY, CONTINUALLY CHANGED HIS EVIDENCE AND FAILED TO IDENTIFY COMMIND POSITIVELY IN A POLICE LINEUP.

CUPRY TOLD REPORTERS WHEN HIS BOOK WAS PUBLISHED THAT THERE WAS NO PROOF THAT OSWALD HAD FIRED THE RIFLE, AND CONTEMBED THAT NO-CHE HAD EVER EDEM ABLE TO POSITIVELY PUT OSWALD IN THE BOOK DEPOSITORY WITH A RIFLE IN HIS HAND.

DECAUSE OF THE REFUSAL DY FEDERAL AGRICLES TO RELEASE EVIDENCE CONCERNINGTHE ASSASSINATIONS, THE COMMITTEE TO INVESTIGATE ASSASSINATIONS HAS BEEN OBLIGED TO LAUNCH A NUMBER OF SUITS UNDER THE INFORMATION ACT.

THE ACT RULES THAT INVEESTIGATORY FILES HELD BY THE GOVERNMENT ARE CHLY EXEMPT FROM DISCLOSURE IF THAT INFORMATION WHICH MIGHT BE IELEASED IS LIKELY TO CREATE A CONCRETE PROSPECT OF SERIOUS HARM TO LAW EMPORCEMENT EFFICIENCY.

THE COMMETTEE IS PARTICULARLY ANXIOUS TO OBTAIN A SPECTOGRAPHIC MALYSIS OF THE DULLET AND BULLET FRAGMENTS SAID TO HAVE DEEN IDSPONSIBLE FOR THE ASSASSINATION OF PRESIDENT KENNEDY AND THE UDUNDING OF GOVERNOR WALLAGE.

THE SUIT IS DEING DROUGHT BY HAROLD UPISDERG, THE AUTHOR OF THE UNITED ASH TELEVISION SERIES. THE SPECTCORAPHIC REPORTS HE IS SEEKING WERE NOT RELEASED TO THE WARREN COMMISSION BY THE F.B.I. THOUGH THEY WOULD PROVE CONCLUSIVELY IF THERE WAS NORE THAN ONE CHIMAN IN DEALEY PLAZA.

FERSTERVALD IS SUING FOR ACCESS TO THE ACCO-PAGE F.D.I. HIPORT ON THE MURDER OF ROBERT KENNEDY.

FENSYMBUALD IS AUXIOUS TO CLEAR UP THE CONTRADICTORY EVIDENCE THAT CHREDITLY MAKETS AND IT ROBERT MINISTRY'S MURDER. ALL THE WITHESSES AGREE THAT SIRMAN WAS SOME DISTANCE IN FRONT OF KENNEDY WHEN HE DESAM FIRMING.

BUT THE CORCUER'S REPORT SHOWS THAT ALL THREE BULLETS WHICH STRUCK THE SENATOR WERE FIRED FROM DEMIND, BELOW AND AT A MAXIMUM TAMES OF SIX INCHES.
