All Jim knows is what Bud says. My experience with Bud is that this does not have to be what he means and that he change change like the weather. Jim said that Bud acted as though he were concerned about what can happen. Whatever the real situation, I decided to do as Jim said and what I sent is what just poured out. It was not designed to please Bud. It is exactly what I have said all along. It is what I told Downing's people and what I told Schweiker in person. Fud had asked me to see him after I saw Schweiker and I did.
