Dear Bud, 8/15/85

In your 8/13 you say that if I can interest Hirschkop you'll take him by the hand and bring him up to Frederick. (Are you both in good enough shape for that long a walk?) "That's the best offer Ican make at the monent." Before suggesting two simple ones in addition, I don't want to forget something seemingly unusual that happened last time I wrote you. I've sent the returned, unopened envelope to you via Jim.

Someone after mailing scrawled through the 1000 in your address and then the envelope was returned for the street to be added. The 1000 could be repet read through the pencil and the Wilson Blud was clear, as was the zip. So, even after someobe took liberties with the mailing it could have been delivered.

I've been after Jim for a year of more to send me Hirschkop's address and he promises and then forgets. Would your please?

What kind of approach do you suggest? You know him better than I do. I can write a very brief, simple letter or I can go into some detail.

He was tempted to take over on my suit against the government for helicopter damage to our farm after Williams abandoned us but he was quite frank and honest. He told me that he had been paying his dues for years, which is quite true, and that he had a wealthy client whou could and would pay him well, and he was off, that night or the next day, for Texas. Later I learned that the client was the Hunt brothers. (Jimmy Ray told me that Percy Foreman died, by the way.)

From the time of his remarkable success for them I've not seen his name in the papers and I've wondered if he prefers to take it sasy, without causes to fight as he did so well.

I suppose you'd considered phoning him for me and decided against it.
