of President Kennedy Is Beginning to Jell I recently attended a conference on the assassination of President Kennedy at the University of Minnesota in Minneapolis. This conference was organized by Professor James Fetzer, who teaches philosophy at the branch of the University located in Duluth. I must say that I was impressed by the quality of the speakers and the people in the audience. These people were highly educated, very intelligent, and socially sensitive. From this alone, I can, at long last, say that it's over with for the killers of President Kennedy, no matter how many more witnesses and researchers they knock off in the days to come (such as Mae Brussell). And no matter how much more they manipulate the U.S. media. This thing has caught fire and there's no putting it out now!

More than anything else, I was overjoyed to hear that the best thinking about the origin of the JFK murder has at long last begun to jell! Participants told me that they now believe that the orders to the CIA to kill President Kennedy came from the Corporate Elite in New York City, sometimes called "The Military-Industrial Complex."

So what was the immediate cause and who in the leadership roles made the final decision? I'm working on the names, but I can tell you now, with no chance of error that two of the five were Rockefellers, David Rockefeller and his brother Laurance Rockefeller. I have long known that my old boss in the State Department, Dean Rusk, had advised President Johnson right after the JFK assassination not to escalate the Vietnam War. What Rusk, McNamara and others did not know was that LBJ was merely going through a pro forma exercise because the decision had been made in New York City before November 22, 1963, and conveyed to Johnson by Laurance Rockefeller. (I used to wonder why Rusk did not resign after Johnson rejected his advice. Rusk had earlier been Assistant Secretary of State during the Korean War, and he knew all too well the futility of another war of that kind, this time in Vietnam. Rusk may have been forced to stay on in the job. Or possibly he had heard that our U.N. Ambassador, Adlai Stevenson, had been murdered by the CIA, because he was so fed up with the Vietnam War that he planned to resign his U.N. post. Stevenson promised that after leaving his post, he would not lead a domestic anti-war movement, but the Military-Industrial Complex feared that he would be drafted, and so it moved in for the kill. I suspect that this is also the reason that former Defense Secretary Robert McNamara refuses to talk to this very day about President Kennedy's orders to him to go to Vietnam and report back that we should wind up the war. McNamara did so, as we all know--except for Noam Chomsky--and it was this move by JFK that brought on his murder.)

But let's get closer to the real motivation. The Corporate Elite was very upset about the near-stock market collapse in May, 1962. On top of this, two of the big banks in New York City that the Rockefellers controlled were about to go into bankruptcy! David Rockefeller was Chairman of the Board of one of them, Chase Manhattan Bank. The Rockefellers knew that a decision to get out of Vietnam would hurt the profits of the corporations whose shares their banks held in massive amounts, corporations making military goods for the war. Chase Manhattan would be hit <u>especially hard</u>. In other words, President Kennedy's decision to get out of the war would <u>speed up</u> the collapse of their banks and <u>wipe</u> out the entire family fortune of the Rockefellers!

The Rockefellers made sure that the American public did not find out about their plans to escalate the war until President Johnson was safely elected and inaugurated on Jan. 20, 1965. They didn't waste any time. The war was escalated 19 days later! And that saved their lousy banks. Between 1965 and 1970, the assets of Chase Manhattan <u>doubled</u>. Who says that crime doesn't pay? But the Rockefellers were really fools to ever think that they could get away with this horrendous crime. Ever since Nov. 22, 1963 the American public has been disenchanted with the way they have run the country. We're in a temporary "good economy" but this had to be generated $2\frac{1}{2}$ years ago for election day by flooding the country with extra paper money. (Whenever this has been done in the past, it has led to hyper-inflation.

it has led to hyper-inflation, followed by total economic collapse!) It's time for each one of us to speak out and to go to work to get control of our country back once again. This isn't going to be easy. Like Dr. King used to say, "There will be some difficult days ahead." Some more of us are even going to be murdered before the dust settles. I often think of the family who lived across the street from us when I was in high school, two children and their mother, the Krauses. Their father had been killed in Europe during W.W.II fighting the Nazis. So many people have been killed here on the homefront fighting U.S. Nazis, and there will be more casualties to come. But we now know who JFK's Nazi killers are and why they made the decision to take him out. Knowledge is power.
