SUBJECT ANTI-CASTRO GUERRILLAS

1. [REDACTED] CONTINUED EVASIVE DURING INTERROGATION. SAYS FRUSTRATED RENDEZVOUS OFF TURNERPEL ISLAND WAS TO BE WITH ONE OR TWO LARGER SHIPS AND THAT COLONEL FRANCISCO QUESADA RPT QUESADA WAS IN OVERALL CHARGE AND PRESUMABLY ABOARD OTHER VESSELS. [REDACTED] SAID HIS COMMUNICATION WITH QUESADA WAS THROUGH A IACB CONTACT IN MEXICO. HE PRESUMES OTHER ELEMENT(S) CONTINUED TO CUBA AFTER FRUSTRATED RENDEZVOUS. [REDACTED] EXTREMELY EVASIVE RE PORT OF DEPARTURE OF "QUESADA" GROUP BUT DOES NOT DENY THAT POINT OF ORIGIN COULD HAVE BEEN HONDURAS OR GUATEMALA. FIORINI MAINTAINS THAT INITIAL AND ULTIMATE OBJECTIVE WAS CUBA WITH NO RPT NO INTENTION OF GOING TO ANY OTHER PLACE.

4. CONSULATE SENT TELEGRAMS TO NEXT OF KIN REQUESTING FUNDS FOR RETURN AIR TRANSPORTATION. SOME FUNDS ALREADY RECEIVED, BUT POSSIBLY NOT ENOUGH TO DEFRAY TOTAL COSTS. ASSUMING FUNDS AVAILABLE, GROUP CONCEIVABLY COULD BE RETURNED MIAMI VIA TWO OR THREE COMMERCIAL FLIGHTS OVER WEEKEND.
