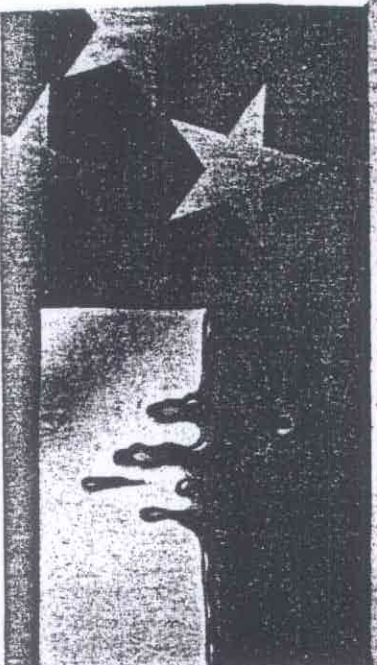

CIA Had Flynt Shot Because He Proved CIA Killed JFK

The shooting of born-again smut publisher Larry (HUSTLER) Flynt was instrumented by a U.S. government assassination team because Flynt investigators uncovered evidence proving the CIA was involved in the assassination of President John F. Kennedy, Flynt's attorney Mark Lane charges.

The attempted murder of Flynt was a last-ditch effort for agents of the ultra-secret squad of trained killers, employed by the government, to silence Flynt. It was the one time when Flynt, as he returned to court in Lawrenceville, Ga., was unaccompanied by his bodyguards. Flynt's wife, Athlea, announced, "My husband believes that it was the CIA trying to silence him. And I

believe it as well."

Flynt's newly acquired publication, the LOS ANGELES FREE PRESS, reveals in its Special Report No. 1 that the killing of JFK was coordinated by the CIA, FBI Lane uncovered

documents proving the CIA framed Lee Harvey Oswald, in order to cover up its own involvement in the assassination.

"Almost two months before the assassination the CIA was establishing a false plan relating to the assassination," Lane reported in the FREE PRESS. The CIA fabricated a story that Oswald visited the Cuban and Russian embassies in Mexico City before the assassination. This, they hoped, would lead investigators to believe the plot to kill Kennedy was a communist plot.

Political activist and executive editor of the FREE PRESS, Dick Gregory, has believed for years that the CIA was behind the JFK assassination. He found evidence that Kennedy was preparing to break up the CIA after the Bay Of Pigs fiasco, and the CIA, fearing for its very existence, had JFK shot and framed Oswald.

The assassination team which gunned down Flynt

apparently was the same one that killed Dr. Martin Luther King Jr. "An identical method of operation was applied in King's murder," notes Lane who spent 14 years studying political assassinations.

Evidently, the CIA had hoped to throw the blame for Flynt's shooting on some religious fanatic who was upset because of Flynt's pornography. But the job was too slick. The gunman, after pumping at least three bullets into Flynt, escaped without a trace.

Luckily for Flynt he was fasting on the day he was shot. He had had only a glass of grapefruit juice for lunch, and the day before, as dictated by his routine, he had two enemas.

Doctors think those enemas helped save his life. When the bullets tore into his intestines, his digestive tract was empty, thus decreasing any chance for infection.

Flynt, from his hospital bed, remarked, "If this will focus enough attention on the concept of obscenity, maybe we can truly have a free press in this country. One single thing has hurt me the most—the American people wouldn't believe me when I said I was willing to die for the concepts on which our country was founded."

Lane reports that Flynt's million-dollar reward offer for new leads in the 1963 assassination has produced important new evidence.

"I now have a top-secret document that is the single most important document uncovered since the Kennedy assassination," Lane declares.

He had promised to release the names of Kennedy's killers, including several CIA agents, in the next edition of the FREE PRESS.
