For valuable consideration, the receipt and sufficiency of which I hereby acknowledge, I hereby agree as follows:

1. I hereby grant to you and to your successors, licensees and assigns, the irrevocable right (but not the obligation) to record, exhibit and otherwise use my name, likeness, photograph, voice and biographical data (a) on and in connection with the Program and (b) in materials used to advertise, promote and publicize (i) the Program and (ii) you, your successors, licensees and assigns, and your and their services and products or the services and products of any sponsors or advertisers ("Advertisers") associated with the Program, but not, however, as a direct endorsement of any such products or services.
2. I understand and acknowledge that you and your successors, licensees and assigns, are and shall be the sole and exclusive owner of the Program, including, without limitation, the title thereof and all rights (including copyrights), components and elements contained therein, for all purposes and uses whatsoever, throughout the universe and forever. Without limiting the generality of the preceding sentence, you and your successors, licensees and assigns shall have the sole and exclusive right to distribute, license, exhibit, advertise, publicize, promote and otherwise exploit the Program or any part thereof and any and all rights therein, whether now known or hereafter devised, including, without limitation, all television, home video, theatrical, non-theatrical, merchandising, music, publishing and all other ancillary or subsidiary rights of every kind, in all media, whether now known or hereafter devised, and by any manner or means, whether now known or hereafter devised, all without any restrictions, limitations or conditions of any kind. You shall also have the unrestricted right to edit the content and text of the Program in any manner or form.
3. I hereby release you, your successors, licensees and assigns, and Advertisers from and against claims or actions of any nature whatsoever arising by reason of: my appearance on the Program, statements made by me or others on or in connection with the Program, or your exercise of any or all rights herein granted. I agree to indemnify and hold harmless you, your successors, licensees, assigns and Advertisers, and your and their affiliated companies, and your and their respective officers, directors, agents, employees and stockholders, from and against any and all claims, damages, losses, liabilities, costs and expenses, including attorneys' fees, arising from the exhibition or other use of my appearance, words spoken by me, or any materials furnished by me, or the exercise by you of any rights herein granted.
4. I understand that Section 507 of the Communications Act of 1934, as amended, makes it a criminal offense for any person involved in any television program to accept or agree to accept, or pay or agree to pay, any money, services, or other valuable consideration for the inclusion of any matter as part of said program without disclosing the fact of such acceptance, payment or agreement. I hereby represent and agree that I have not accepted or agreed to accept or pay, and I will not accept or agree to accept or pay any money, services, or other valuable consideration, for the inclusion of any matter, including but not limited to, the name of any person, product, service, trademark or brand name, as a part of my appearance on the Program.
