FINDINGS: SEGMENTAL PRESSURES WERE PERFORMED BILATERALLY FROM THE LOWER EXTREMITIES. HISTORICALLY THE PATIENT HAD LEFT FEMORAL POPLITEAL BYPASS GRAFT IN 1980. SEGMENT PRESSURES SHOWED SEVERE DECREASE IN ANKLE/BRACHIAL INDEX OF THE RIGHT OF .51 AND ON THE LEFT .43. MAJOR DECREASE IN PRESSURE OCCURS ACROSS THE LEFT ILIAC AND COMMON FEMORAL SYSTEM WITH FURTHER BUT LESS SIGNIFICANT DROP ACROSS THE LEFT POPLITEAL ARTERY SYSTEM. ON THE RIGHT MAJOR DROP IN PRESSURE OCCURS ACROSS THE RIGHT SUPERFICIAL FEMORAL ARTERY WITH LESS PROMINENT BUT FURTHER DROP IN PRESSURE ACROSS THE DISTAL ARTERIAL BEDS.

DOPPLER FLOW WERE NORMALLY TRIPHASIC IN THE RIGHT EXTERNAL ILIAC ARTERY WITH MONOPHASIC FLOW FROM THE RIGHT COMMON FEMORAL ARTERY TO THE DISTAL ARTERIES. MONOPHASIC FLOW WAS NOTED IN THE LEFT EXTERNAL ILIAC, COMMON FEMORAL, POPLITEAL AND POSTERIOR TIBIAL ARTERIES. THERE WAS NO FLOW FOUND WITHIN THE LEFT SUPERFICIAL FEMORAL ARTERY NOR ON THE LEFT FEM-POP BYPASS.

INTERPRETATION: 1. SEVERE BILATERAL MULTI-LEVEL ARTERIAL OCCLUSIVE DISEASE WITH PROBABLE TOTAL OCCLUSION OF THE LEFT SUPERFICIAL FEMORAL ARTERY AND PROBABLY SIGNIFICANT BLOCKAGES IN THE LEFT EXTERNAL ILIAC, BILATERAL COMMON FEMORALS, RIGHT SUPERFICIAL FEMORAL. 2. TOTAL OCCLUSION OF LEFT FEMORAL, POPLITEAL BYPASS GRAFT AS NO FLOW WAS FOUND. 3. SEVERE BILATERAL SMALL VESSEL DISEASE EVIDENCED BY DECREASE TOE PRESSURES BILATERALLY .47 ON THE RIGHT AND .50 ON THE LEFT .
