I also enclose an article written by myself which relates to the JFK assassination. As a 14 year researcher, I am dedicated to avoid a repetition of the perpetuation of the COVER-UP which was originally perpetrated by the Warren Commission in the JFK case and the Justice Dept. in the King case, and I would hope this letter is circulated to EVERY member of the Select Committee, and that yhis matter is brought to the immediate attention of Robert Blakey as well.
