

DOCUMENTED EVIDENCE ON THE JFK ASSASSINATION (11/22/63)

1. Two-thirds of the witnesses ^{mentioned} said that at least one shot came from the grassy knoll area in FRONT of the President.
2. On the day of the assassination, the doctors at Parkland Hospital noted that the wound in the throat was one of ENTRANCE.
3. The original notes made during JFK's autopsy are missing.
4. The ONLY A-P X-ray of the skull is burned in two places, and nowhere is there a record of who did it, how, when, or why.
5. No clear, frontal pictures exist of the throat wound and tracheotomy.
6. The three autopsy doctors, Humes, Finck, and Boswell, stated in a report of Nov. 10, 1966 that a roll of 120 film "was seized by the Secret Service agents ... during the autopsy and immediately exposed to the light". About this destruction of evidence by Government agents, not one official inquiry has been heard.
7. The 1968 Clark Panel, in examining the X-rays and photos taken during the autopsy, said there were X-rays missing; the entry hole in the rear of the head was four inches higher than where the autopsy doctors had placed it; the wound was a completely different size and shape than that described by the autopsy doctors; they saw an unidentifiable "gray brown rectangular structure measuring approximately 13x20 mm" in a picture of the base of the brain; they saw an "elliptical penetrating wound of the skin of the BACK"; and they reported "several small metallic fragments" in the region of the lower neck - missiles which Humes swore earlier were not there --- YET THE PANEL CLAIMED TO HAVE CONFIRMED THE FINDINGS OF THE WARREN REPORT !!!!!
8. In his testimony at the trial of Clay Shaw in 1969, Finck admitted that the President's autopsy was not "a complete autopsy under the definition used by the American Board of Pathology." He further stated that the autopsy doctors were ORDERED by a Navy Admiral NOT to trace the bullet path through the neck - without which there can only be ASSUMPTION of where the bullet actually went. Why the military interfered with the doctors in a President's autopsy has never been officially questioned.
9. The autopsy report was revised with many substantive changes and handed in AFTER Oswald's death.
10. The paraffin test exonerated Oswald from the assassination, almost surely.
11. The Warren Commission, as a general policy, did not call witnesses whose testimony would have been favorable to Lee Oswald. Some examples are: Carolyn Arnold, FBI agents Sibert and O'Neill, Charles Brehm, Julia Mercer, Aquilla Clemons, T.F. Bowley, and Avery Davis.
12. The Warren Report stated things known to be false - such as that the bullet "exited through the front of his shirt immediately behind his tie, nicking the knot of his tie in its forward flight". In an FBI Report of Dec. 5, 1963, it states that "No bullet metal was found in the fabric surrounding the hole in the front of the shirt." This precludes the possibility that the hole was made by a bullet and the Commission knew it. It also had been told by Dr. Carrico that the wound was above the collar and tie knot.
