

On November 22, 1963 President John F. Kennedy was assassinated in Dallas, Texas. The Warren Commission concluded that a lone assassin, Lee Harvey Oswald, committed the crime - as well as murdering Officer J.D. Tippit. The assassination was a political crime. Power did change hands on that day. A new administration came into being and the course of history was irrevocably changed. Is it only coincidence that the ~~last~~ ^{previous} three elections have been decided by bullets and not ballots ?

The 26 Volumes of Hearings and Exhibits of the Warren Commission are filled with useless trivia such as Jack Ruby's mother's dental chart, but lack such vital information as a complete autopsy report of a murdered President. WHY ???

Among the many doubts, raised by responsible people who search for the truth, are these:

1. Why did 2/3 of the witnesses to the assassination claim shots came from the front ?
2. Why did the revised autopsy report claim a bullet exited the throat, when no path was traced, and when all the doctors who saw it called the throat wound one of ENTRANCE ?
3. Why did Givens, the only man to place Oswald on the sixth floor, only "remember" that after some months ?
4. Why did the Commission discredit Eddie Piper's testimony that he spoke with Oswald on the FIRST floor at noon - after Givens supposedly saw him ?

5. Why did the Commission never call Carolyn Arnold as a witness? Is it because she said she believed she saw Oswald on the FIRST floor around 12:15 - when a gunman was seen on the SIXTH ?

6. Does the Altgens picture show Oswald in the doorway during the assassination? Billy Lovelady claimed it is he, but an FBI report claims he "stated he was wearing a red and white vertical striped shirt", short sleeved, while the man in the picture has on a long sleeved dark shirt identical to the one Oswald wore when arrested.

7. Why did witnesses to the Tippit murder describe the killer as 5'11", black, wavy hair, wearing a white shirt, when Oswald was 5'9", had brown, unwavy hair, and wore a brown shirt ?

8. Why did the paraffin test uphold Oswald's statement that he was innocent ?

9. Why is there NO tape or stenographic record of ANY kind of Oswald's interrogations ?

10. Why does the PSE test show NO STRESS in Oswald's voice when he denied shooting ANYONE - unless perhaps he is what he claimed to be all along - INNOCENT of the charges ?

WE, THE PEOPLE, MUST DEMAND AN IMMEDIATE END TO THE CONTINUING COVERUP OF JFK'S ASSASSINATION AND DEMAND INTEGRITY IN GOVERNMENT. OTHERWISE THE PEOPLE IN POWER WILL CONTINUE THEIR POLICY OF DISTORTION, SUPPRESSION, AND FABRICATION.
