I can understand your frustration but I really can't relieve it. Just do not give in to it.

Please also understand that these court suits not only produce records, they take much time but they are also a backup for a finking House investigation.

Unless you can use some of their visuals stay away from those you have mentioned. Well, I do not know what the CCI sent you but there is nobody less dependable than Lane. Steik to my work and the Meagher and Roffman books. They are solid. You will not mislead people if you draw on them. Feel free, if you'd like, to make slides from any of my pictures and facsimiles. An offset camera can double the size in each direction while eliminating the photoengraving screen. For small audiences this is better than slides. I used to dom it all the time, mounting the pim on a staff backing.

Thanks so much for answering. I would not want to walk in your shoes; my own are frustrating enough! You are in a very bad situation as far as public relations go. You're right - your work should come first. The only trouble is (from my point of view) that there is nowhere to go for the answers that one needs to pursue the truth. I recieved some helpful stuff from the CCI, feel that the AIB does not know enough to answer more than novice questions, and wrote to the Comm. to Investigate Assassinations. Never received anything and my call was not answered. I want to know the facts - I don't want to go off half cocked and spread false information. You know all the crank stuff that has been written. All the crap has to be thrown out and the facts kept.

Damn, I wish I could help! That does you no good, I know. I feel that your work has been invaluable in this matter. Aren't there people who live in your area who are interested enough in this case to work with you and really help out? I would think that there would be many people in your area who would love the chance to work with you in some way and to help you. Maybe their energy needs to be directed.

The press and the media are worse than useless in my opinion. I can't believe all these people are just ignorant of the facts. Too much has been revealed and is available to them if they will but look for it. They still print only the garbage and only such statements as Lattimer's. I look eagerly for any news on the matter and I have not seen or heard of any press conferences by you. Think freedom of the press is a colossal myth these days. Everyone (almost) wants simple solutions to the most complex problems. The investigative work only seems to go so far - as far as the people in control let it. Funny how the police and FBI know all the Mafia's name and what region they control, etc. but they never arrest them and get them to jail. A kid who smokes a joint winds up with a prison term. It all depends on who has the power and now we are in very sad shape. Congress was the last hope as far as the JFK case went. If they are as you say, then only more garbage will be forthcoming. I know I could conduct more of an investigation than what they are doing. I really don't see what the big problem is, but apparently they are incapable of doing it.

I belong to Mensa as I mentioned to you, and gave a talk with slides and the Zapruder film before a small group of Mensans. The editor of the state newsletter also attended the meeting before the League of Women Voters. I told her I had heard from you and she suggested that I ask you if you would like to write an article, up to perhaps three typewritten pages, for inclusion into the state newsletter, Mains'l, which is also circulated around the country to an extent. When I started this letter I was going to tell you that I certainly did not expect an answer back, but now that this has come up, I'd like to know if you'll consider it. Enclosed is a SASE and a couple of extra stamps. On January 28, I'll be giving another talk in Oakland, Me. for a small number of interested people. After one of my letters appeared in the paper I got a letter from a woman there who also has been extremely interested. She wanted to know my sources, and we have corresponded regularly since. She is setting the thing up and the previously mentioned editor expects to go with me. So hopefully a few more people will know some of the details the press never mentions. I hate to even ask this, and if you do not want to take the time to answer I will understand - but where you were asked about the article and will answer that (I assume), heck, I'll try - is there anything new to report? Spectrogaphic data still locked up and unanalyzed? Any new classified stuff out? There is no news on this and you are the only one I CAN ask. Sorry.

Like I said before, any new book you get published, please send! Take care, Mr. Weisberg, and I certainly hope you are well and I wish you and your family the happiest holidays ever! Peace, love,
