ANTICIPATED LECTURE PLANS REGARDING
PRESIDENT KENNEDY'S ASSASSINATION

Reurlet dated 6-14-76, with enclosure, wherein you requested Bureau advice concerning any legal restrictions which might be applicable to SA Gemberling's plans, upon retirement, to lecture for a fee to civic and college groups on President Kennedy's assassination, more particularly, his intent to draw upon his FBI experiences and declared desire to utilize certain Bureau records to implement his presentations.

Your attention is invited to the Manual of Rules and Regulations, Part II, Section 8, which sets forth the provisions of Departmental Order 3464. This order provides, in part, that FBI files and information are confidential in nature and, except upon specific authorization of the Attorney General, no former employee of the Department of Justice shall furnish to any person outside the Department of Justice any information obtained from the Federal Bureau of Investigation; further, that the contents of official files, documents, records, and reports shall be disclosed only in the performance of official duties. It should also be noted that Special Agents sign an agreement (FD-291) in consideration of their continued employment, to maintain such information in confidence both during their employment and afterward.

Naturally, to the extent that FBI documents have become public documents, due to publication in the Warren Commission Report, release pursuant to the Freedom of Information Act, or their

Aside from the above considerations, there do not appear to be any legal restrictions applicable to SA Gemberling's plans.

Re Dallas letter to Bureau dated 6/14/76 captioned as above outlining the plans of SA GEMBERLING to lecture on the investigation of the assassination of President KENNEDY after his retirement on 12/31/76, and Bulet to Dallas dated 6/25/76, outlining the legal restrictions applicable to such plans.

Enclosed for the Bureau is a copy of the brochure to be sent to many colleges throughout the country and a copy of the form letter to be utilized for the transmittal of such brochure.

The Bureau is being furnished a copy of this brochure and cover letter for its information. It is suggested the Bureau may desire to alert all offices to the contemplated plans of SA GEMBERLING. It is anticipated such offices may receive inquiries concerning SA GEMBERLING and his lecture presentations.

SA GEMBERLING plans to point out in each of his lectures that his appearance and comments are made as a retired Special Agent of the FBI, who is now able to express himself publicly; that his remarks are not endorsed by the FBI; and that
