Dear Gerry, 8/30/90

I've forgotten the details of what I sent to Kevin Walsh and I've learned a little more since then so I'll tell you the whole story and in so doing will have a file copy.

Kevin is a professional criminalist. I've known him since shortly after he got his degree. He has his own agency in Washington now, The Capitol Hill Agency. He was on the staff of the liouse assassins committee. In the mail one day I got from him, without any covering letter, copies of the Marines records of Roscoe Anthony White. - noticed as soon as I looked at the first few pages that he'd gone to Japan on the same ship on which Oswald went and at the same time. He was classified as an auto mechanic and had such an assignment in Japan. Along with it was an untitled document that I took to be a summary of a book or a TV documentary or both. This turned out to be correct. I wrote Kevin promptly but before he got my letter in the next mail from him there was his investigtive report on some at checking he'd done on Roscoe and his son, Ricky. I am inclined to think that this was O'Reilly and when - heard his voice and name I remembered that years ago he'd used me on a Conn. TV station he was one I've not tried to check the files in part because I don't recall the call letters, which is how I'd have filed anything, but maybe he did something then I didn't like and let him know. There has to be some explanation for his dishonesty. I do not think it could have been others on the production staff because the woman who was in touch with me several times phoned me from lew York after she saw what they got by attained satellite to tell me how good it was and more, that the two bigshots of that syndication outfit, which includes top shows like Wheel of Fortune, happened to see it and liked it very much. She told me that she was going to propose that they do an entire show on me. I'm not holding my breath! The staff here apparently told them in wiew York what I have here. They could hardly believe it. But anyway, I did get to say much, much more and it was edited out.

Because Kevin had asked me to keep the stuff about the book/documentary outline confidential I could not flash and quote it but I was lucky and knew enough, as with the Tippit fabrication, to do the scoundrel in. As soon as I knew off the Timet story and then was told by Gary Eack that there would be a press conference in Dallas I asked a friend on the Balt. Sym to send me what AP had on its main wire. That came just before the TV crew and I'd had enough time to skim it and use a highlighter on what I wanted to spot on camera. That was my source on duby and more. This fakir claims he was tipped off by a fellow conspirator (who kevin located and interviewed and says Ricky is a liar seeking to commercialize the whole thing) who said they were both CIA contract employees and two of the three JFK assassins. The third he said was "Saul" and Saul was in the Courts bldg. and shot from there. They were to have escaped through Red Bird airport. hany years ago a friend who is a publishing lawyer, rather then was, in New York, phoned me and asked if I'd read a 65-page summary of a JFK assassination book and give him a verbal report by phone. I agreed. And was well paid, by the way. I hadn't gone very far before it was clear that the book was a complete fake. I also was a bit apprehensive about the possibilty that perhaps his publisher was being set up. I've been asked to keep the name confidential but if I could tell you, you'd know immediately that he could have government officials who did not like some of what he depublished. So I asked for and got a small expense allowance, for phone calls only. By the time I was finished I had three versions of the summary. In two versions LBJ was behind the assassination. That was removed in the third, and in the ghost-written book, and I knew why, who suggested it. I know that guy. Bud Fraster will was behind that white I was finished.

There were real people in that book and by coincidence we were friends with the lady friend of the one villainized in the book. He was dead so no libel. We got to meet another who was involved or they'd not have dared use his name. When the lady told him about what I was doing he came up from Washington and took us to dinner and a long talk.

Dear Harold,

Aug. 7, 1990

I happened to be watching the NBC evening news this evening, trying to follow events in the Middle East. Immediately following is Inside Edition which airs on the NBC-affiliated station down here. I caught your brief appearance and the critical remarks you made concerning the latest revelation as to who killed JFK. I thought what you had to say, all too brief, made sense and perhaps will make a few people question this story. It seemed that all they could counter with is: just look at us, don't we look like nice decent folk. Why would we want to make up such a story? Even Bill O'Reilly seemed to support such a view. It is too bad you were not given more time to elaborate on your response, "why not?" And it is a shame you could not make at least one or two more critical comments. But given the state of the media today, how can anything of real depth ever be said and made intelligible? I thought it was ludicrous of O'Reilly to say at the end that we can let the American people decide, now that this program has shed such great light on this story. Hogwash!! I have felt so frustrated with some of the brief media appearances I have made, and I am sure you have experienced such frustration on numerous occasions. But for what its worth, I believe you came across well in the few minutes (or should I say, seconds) that you were on the air. One final note: it seemed that neither Ricky White nor his wife had any idea who you are. They may be completely ignorant of all that you have done to challenge the FBI and the Warren Commission's cover-up and deception. Although I am sure you probably will anyway, I would like to hear more about this latest expose. I did receive a letter from you yesterday in which you included some of your correspondence with Kevin Walsh in which you made some remarks about this story. I was completely unaware of it until I got your letter and until it was mentioned by some friends of mine at a poker game last night.

I am still plugging away at the sanitation strike files. It has been going slower of late because I now have to begin preparing for a new semester of classes. I did run across one of those infamous "blind memos" which was to be leaked to cooperative news sources. I thought it grossly distorted King's involvement in the first march on March 28th. It seems to me that their own intelligence contradicts such accusations that King forced himself on the COME group in Memphis, in addition to trying to suggest that he may have indirectly encouraged some of the violence. One question I have: I assume that all the names which apppear in those memos are indexed and possibly made use of later, even of people who were never accused of any crime or of those accused but never proven guilty in court. I have also noted a fair amount of repetition, for example I have read at least 5 or 6 accounts of some remarks Rev. Lawson made which suggested there might be something good about Communism.

I have not met with my history colleague yet to discuss Med

Melanson and see how he is doing with Frame-Up and some of the other reading. But I am sure I will fairly soon. I would be interested in the notes you made on the Murkin Conspiracy. But there is no hurry and please let me pay you for the xeroxing if it is a lot.
