Thanks for the recent letters which included your analysis of the White House phone logs and a copy of your essay in response to the Amer. Hist. Review forum. Both were informative. Although the librarian I spoke with at the LBJ library said that there had been other requests for that information, I don't know if anyone else has used it to rebut Crenshaw's book. I thought your essay to the AHR was good, especially in that you effectively put together the whole story of your criticism of Stone. This will be especially helpful to me as I put together an outline of the project on Stone's film I plan to teach next Jan. '93.

Another school year came to a close here this past Sunday with graduation ceremonies. The past week and a half I have been fighting a bad cold and trying to get final exams graded and final grades in. It tends to be a real rat race at the end, as I am sure Jerry McKnight can testify. During the next month I am going to be involved in a seminar on Africa and the African-American experience. There will be a couple of visiting professors from Senegal conducting some of the classes. I will be giving some presentations toward the end on Malcolm X, King, and a final class on the L.A. riot.
