Dear Harold,

Thank you for your advise on how I might proceed with C, and the Phoenix School students. I will try to work towards a meeting between you and C. as quickly as possible. I just can't say for sure if he would talk to you, but your ideas of demonstrating your trust are going to help. He might be in need of a job, something to get him over the hump of "there's really nothing legal that can be done, and besides I'm safe". It's just an idea, but perhaps the Hitler-Miami tape dialogue might loosen him up. He didn't know much about it when I mentioned that such a tape existed (and I didn't remember the bit about Davies following MLK). I'll see him next Thursday and I'll throw some things around to see what he thinks now. He's pessimistic about JFK, because most of the principles are dead, missing, or tucked away. It would take a confessee to generate interest again. At any rate, I still think he might go on MLK.

I am heading up a committee to get you to Seattle as soon as we get the funds. Please give me some idea as to what you will need for money. And if you have a fixed schedule in March or early April. The director of the Phoenix School was impressed by the books you have written so far

and is real interested in having you address the school and various university groups who are backing Phoenix.


As to the series of talks planned, I intend to stick to Dealey Plaza since it would be hard for the kids to follow an analysis of the critics New Orleans work and your Commission work. I am going to work up an outline of what I will cover and send it to you. I would greatly appreciate a critique and any other comments you care to make on it.

My last letter to you too rambling, I should have stuck with C's comments about what Hooty had told him. I don't quite understand why Hooty slipped notes under LHO's door either. I am wondering if C misunderstood Hooty and Hooty meant that he left notes for Oswald in LHO's P.O. Box. That would make more sense. What doesn't make any sense, if the Bureau was not in the planning of the assassination itself, is why they would be so lazy about checking LHO out in light of Vallee, Groth, and the rest of the Chicago cast. What C told me about Hooty's stake out failures convince me that some of the Bureau's people aren't exactly supermen but its just too much to believe that they are all dolt. I'm real interested in that color print taken by Army intelligence man Powell. Its odd indeed that these military people show up all

the time. Do you know anything that would link the inter-agency intelligence pool called Code "CONUS-INTEL" (Continental United States Intelligence) with MLK's death. I believe that C. implied that the NSRP was heavily infiltrated with U.S. people on all levels of leadership and used. I can cite examples of this use of radical left groups. It stands to reason the right can be moved about by the level of infiltrators too. When I write next, I'll give you examples of how the feds used a Seattle group called the SLF (Seattle Liberation Front) to provide a real Reichstag fire here. The irony of it all is that the people who founded the organization actually believe that the tactics they used were formulated by themselves. I strongly suggest you look into the backgrounds of various racist organs, and look for people who are quickly converted to that group's ideals, and just joined after military service. Two informers from the Seattle group entered the group right out of domestic military service. (one re-upped)

Do you know of any way I can get a hold of Dealey Plaza photos for my school deal. I am wondering if this man sprague would lend me copies or sell them to me. I am particularly interested in Willis' picture. That weird black shape of a man is too slack a tone. See insert.
