MISC; INFORMATION CONCERNING

On 8/29/75 an individual who identified himself as GARY GOUCHNOUR, residing 212 Filmore, New Orleans, La., appeared at the New Orleans Office of the FBI. Mr. GOUCHNOUR stated he at one time was a student at Tulane Law School and at that time related incident involving what he thought to be the KENNEDY assassination and his, GOCHNOUR's, possible contact with OSWALD. He stated as a result of his furnishing this information, he was refused to continue his studies at the Tulane Law School, and although he has applied for reinstatement on numerous occasions, he has never been allowed to again attend Tulane Law School.

Mr. GOUCHNOUR rambled at length about the U. S. Government, in a critical manner. He was critical of the FBI and the CIA, as well as the Veterans Administration. He indicated the VA "lost" his dental record where they were at fault in extracting a tooth. He stated he worked for the Social Security.

Mr. GOUCHNOUR rambled at length about an incident wherein he was at the Town and Country in New Orleans during the time of the Kennedy assassination; that he picked up a package there and went on to Dallas. He then stated that DAVID DUKE, local leader of the Ku Klux Klan, approached him and stated he desired to talk with him. His thoughts are vague; however, he did stated he talked with the FBI in Seattle, Wash., subsequent to the Kennedy Assassination and told them (he thinks an SA ST. JOHN), about the incident in New Orleans at that time.

The above is set forth in the event Mr. GOUCHNOUR should again attempt to contact the FBI.
