Dear Mr. Weisberg,

Thank you for your letter of 1/29. I send much sympathy to you for these days and weeks of phlebitis. With all your problems and little help, I can imagine how rough it is. I've got problems not so very different - aches in the arms and legs as a result of a cortisone-like medicine having worn off. Have never had arthritis, but this generalized inflammation is a llook-alike for it, if not the genuine article. No help, natch.

I value your comments on the general situation of assassination research and particular persons involved in it.

These last few days I've been thinking about that extraordinary decision to deploy squads of investigators and seads of money to find out who passed the "Pike" Report to Daniel Schorr. It seems to me an echo of the Pentagon Papers affair. It's my opinion that Nixon never cared one way or the other about the publication of those P. Papers, which reflected badly on previous Democratic Presidents, not on him. The whole thing seemed to have been a pretext and a "front" for the investigation of leaks on quite another matter, and other activities in regard to that matter. In the same way, I think this coming House Ethics Subcom. investigation will actually have a different focus and purpose from its ostensible one. Also that it will prove useful for the further investigation and intimidation of Congressional staff members, Representatives and Gov. workers generally.

I made another attempt to secure a couple of prints of the "Aldredge" bullet, hoping I might be able to send you one. But have received no answer to my letter to M.Herren in New Orleans, althouthe letter was not returned to me. I run into conflicting statements as to the angle of that apparent bullet hit.
