October 8

1. Discussed with Mr. Griffin and Mr. Jenner by telephone proper wording of two places in the Report where Hunt Food Products is mentioned. Notified them of steps already taken to secure accurate information and rewrite the sections involved.

2. Arranged to send subpoena to Elgin State Hospital to permit use of medical documents pertaining to Fannie Rubenstein.

October 9

1. Sent letter to FBI requesting a list of physical exhibits held by FBI.

2. Checked with Immigration and Naturalization Service clearance for publication of Naturalization Certificate.

3. Received call from Mr. Skora of CIA concerning the reprinting of Commission Exhibit pictures by private publishers. Time-Life is apparently dunning these publishers for use of pictures taken from Zapruder film.

4. Received call from Mr. Randolph, General Counsel of Hunt Food Products in California. Mr. Randolph said he would send in sample labels from H L H Products items.

October 12

1. Discussed with Messrs. Rocca and Dooley problems connected with publication of certain Commission Exhibits.

2. Discussed with Mr. Rankin the problem of publication of exhibits in future volumes. Mr. Rankin said that as a general rule we ought to try to publish two exhibits per page but that where there was any question about the readability, the exhibit should be published singly per page.

October 13

1. Notified Mr. McKendrie of GPO of Mr. Rankin's decision on publication of Commission Exhibits.

2. Notified Inspector Malley of the article in "New Leader" by Columbia researchers pertaining to witnesses to the Tippit slaying.

3. Received call from David Parsons, USIA, concerning Time-Life's attitude on publication of Commission Exhibits taken from Zapruder film by private publishers.

October 14

1. Notified private publishers of changes to be made in the Report in future printings by GPO.
2. Received calls from Mr. Redlich and Mr. Slawson concerning errors in the Report which should be corrected. Most of these had already been caught and GPO had been requested to make the changes.
3. Received call from State Department Training Division concerning plans for publishing the Report in Spanish. Explained that this office had no plans or responsibility for any further publication of the Report in foreign languages.

October 15

1. Discussed with Mr. Dooley of CIA certain Commission Exhibits.
2. Listened to dictaphone belts and audio tapes pertaining to press conferences of Dallas officials.

October 16

Discussed with Inspector Kelley Secret Service documents to be used as Commission Exhibits.

October 19

1. Received list of physical exhibits from FBI and arranged to have it categorized by Miss Bottum.
2. Discussed with Inspector Malley and other FBI agents documents being used as Commission Exhibits.

October 20

Discussed report briefly with Mr. McCloy. He borrowed and read articles in "The New Leader" and in the British publication "Peace News."

October 21

1. Received call from Gordon Chase at the White House. He asked that we answer correspondence pertaining to the report received at the White House and to return to him any letters we thought required further action by the White House.

2. Received call from Time Magazine asking about the number of volumes of Hearings and Commission Exhibits to be published. Told Time that 25 or more volumes would probably be published sometime in November.

3. Received inquiry from Parade Magazine concerning release of tape made by Mrs. L. B. Johnson concerning events in Dallas on November 22. Parade requested that a transcript of the tape be made available to it for publication in November. I informed Mrs. Ginn of Parade that this could not be done without a request from Mrs. Johnson.

4. Received call from the office of Mrs. Johnson's secretary, Mrs. Carpenter, asking for release of transcript of the tape to Parade Magazine. I asked that this request be sent to us in writing.

October 22

1. Continued to work out adequate substitutes with FBI of documents used as Commission Exhibits.

2. Received call from Mr. Parson, USIA, concerning pictures taken from the Zapruder film and existence of any correspondence between the Commission and Time-Life concerning publication of pictures made from Zapruder film.

October 23

As a result of a call from the Pentagon concerning NBC tapes and films held there, made call to Mr. Monderer, NBC Washington representative, to advise him that these materials have not yet been picked up by NBC. Mr. Monderer said that he would take care of the matter.
