Dear Harold,

I received your letter of Nov 20 today. I am at this very moment recording a Courtney show (Penabaz guest). I will send the tape out as soon as possible (Monday or Tuesday). I am recording the show intact including commercials (I am cutting out the News intermissions). You might want to know who sponsors the shows. The tape should run about 3 hrs. I have spliced a few minutes worth of tape that I recorded Nov, 10. 11:20 PM. WTVJ (4) television. It's an interview with Jim Bishop. Larry King interviewed him regarding his new book. It may be of interest. It will appear first on the tape. I recorded at 1 7/8 ips and only on two tracks. If it doesn't play on your Concord (which I think it will) it will definitely play on your Volence.
