Dear Trent,

Here are four stamps. If my credit is good for a penny, please send me your item 31, 9/17/68, NYT. Good idea if it works out for you. I never see the Times, can't afford to subscribe.

I keep hearing of this big thing you have on the King assassination and Ray. Sure it is true, but from what I've heard, you should have used it by now. If and when you do, how about sending it to me so I can consider adding it to COUP? I have some things on that, including what may be exculpatory information. I've called him "Oswald" and a decoy from the first, etc., as you may recall.

Forgot whether I told you, but as you talk to publishers, I could do a book ~~ON AGENT OSWALD~~ real quick. I have much unpublished. If I could do it as I'd like, I'd do a three-part book, really three in one, with two of them a little shorter. The entire book would not be short. I've 30,000 ~~words~~ of one aspect done, in draft, that is. One part would be on Oswald as an agent, the second on Wesley Liebeler, and the third on what no one has even begun to understand, the executive sessions. This is the part I've got so much written on. I've more to write on it. I'm waiting before doing more writing for several reasons. First, to make the place more habitable and because I need the physical exercise very much, I'm spending part of every day working outside. You can now come in the lane without tearing a car up. You can see the prettier trees because I'm taking the trash out, etc. I've urgently needed the exercise and the added sleep it permits. I have much new data for COUP and I'm expecting more, so I'm waiting for all of it to be in hand. And I'm expecting the representative of a publication, who may not come at all. When I write, I do it intensively and I do not like interruptions, so I'm delaying so I can concentrate.

Off the top of my head, if you want to see what I've got done, why don't you and Carol take a long weekend and drive down here? If you are a fast reader, you can read the four manuscripts I have. We can put you both up. You can see the incomplete Lane ms, too, if you'd like. I've put it aside, after getting the essence on paper. The more I think of it the more I become convinced doing something about Mark will be necessary to our survival. I will not do anything until I can do it thoroughly. I've more to add to that, too, but again a caveat. The irrefutable evidence piles up I am now absolutely convinced that he will be the means of acquitting Shaw. He has, and either doesn't understand or doesn't care, what he should take as evidence of this. He boasts of it for a different reason. Throughout the country there are people who have a glimmer of what he is doing and they send me his remarks. He is boasting of FBI agents in the control rooms when he (and Mort) broadcast. This certainly is not because of all the hot stuff he is bringing to light, for he has never done any of that. It is for the other things both say that will be used in court. The agents are eye-witnesses, not just taping off the air, as they do with me, so they can take the stand and certify what they saw and heard.

My own work is, I think at the point where, if we could get a foundation interested and we could get Hal here from California to work in the Archives for a month or two, in files I would direct him to, and I could keep writing, we could make the most sensational advances. As an alternative, if I could get a good lawyer really interested, I think I have enough to break this whole thing up in court, assuming the temper of the times permits any breaking up. Vince agrees what I now have is the most important yet, from just what he has seen, which is not all. John Christian says COUP is the definitive work, says everything there is to be. I do not agree, but I like it! Best to all,
