ARMAGEDDON PRECIPITATED

" See now what the bold man did  
and dared in the wooden horse,

March 6th, 1970 was a clear, sunny Friday which promised the advent of an early Spring to New York City.

At noon that day, the neighborhood immediately surrounding a 125 year old Greenwich Village town house, located at number 18 West 11th Street, was shaken from its normal lethargy, by a series of violent explosions.

The first blast rocked buildings which were in the vicinity of the town house from where the explosion emanated. Splintered boards, bricks and shattered glass rained through the air leaving what had just seconds before been an expensive brownstone structure, a collapsing inferno.

Moments after the initial explosion, two young women were seen fleeing from the scene of the carnage.

A second and third explosion sounded deep guttural detonations in quick succession as the gas main went up, causing the remaining floors and walls to cave in with an audible rumble as though a symbolic anti climax to the explosions which preceded.

There was little that police or firemen, who had arrived at the scene could do except to keep wide-eyed spectators at a safe distance. When at last firemen thought it safe, they gingerly began the grisly chore of picking through the wreckage. They found the charred body, later identified as Theodore Gold, 23, and the decapitated torso of a young woman, missing her hands a foot, and heavily riddled with large roofing nails. From a little finger found amidst a clutter of bricks and charred timbers, they identified the body as that of Diana Oughton, 28 years old, a student radical. Three days after finding the first torso, another was exhumed, that of a young male, who has since been tentatively identified as Terry Robbins, a radical leader at Kent State University in 1968.

Found along with the corpses were reams of pamphlets of the Students For A Democratic Society ( SDS ) and of a splinter group, The Weathermen. The ruins of what had apparently been a makeshift workshop contained 57 sticks of 60% dynamite, 30 blasting caps, lengths of doorbell wire, several clock work time mechanisms and four crude but deadly fragmentation grenades, lengths of plumbing pipe stuffed with dynamite and roofing nails and sheathed with friction tape.

The town house was the property of James P. Wilkerson wealthy owner of a chain of Midwest radio stations, who was conveniently absent on a pleasure cruise aboard his private yacht at the time of the explosion. His daughter Cathlyn Platt Wilkerson, 26, a member of the Weathermen, was using the town house while he was away. She had graduated from exclusive Swarthmore College. She reportedly did well academically, but like so many young people sent off to attend colleges and universities in America, she too was radicalized by left leaning Professors and fellow students, and eventually brought along by stages of radicalization to a psychological state of what could only be described as nihilism. Her story in the " movement " is a stereotyped one as most are. She began helping in so-called civil rights actions in the streets of Chester Pennsylvania. She ultimately joined SDS and worked for eight months as editor of New Left Notes, an SDS organizational publication. She was one of three SDS leaders who made an abortive trip to Hanoi in 1967 but were turned back in Cambodia.

In the Fall of 1969 along with Kathy Boudin ( believed to have been the other young woman to have escaped the explosion ) led a black contingent of the Weathermen during their so-called " Days Of Rage " demonstration in Chicago. During the demonstrations which ensued she managed to get herself arrested for assaulting a city policeman who was attempting to help control the situation.

Julian Wilkerson, is the daughter of Leonard Boudin, a lawyer long involved in left-wing causes, her uncle is liberal journalist I. F. Stone, an aged Democrat of the new left; Her father Attorney Leonard Boudin has made a career out of defending anti-American characters such as Communist Party member Paul Robeson, accused espionage agent Judith Copland, and Marxist legislator Julian Bond, in legal cases. Leonard Boudin is presently a sponsor since the bomb making episode in his building of a Communist Party-Trotskyite united front group called, ironic as it may seem, The Committee For Defense Against Terrorist Attacks; (right-wing terrorists of course).

In 1961, Miss Boudin went to the University of California at Davis for a summer to study microbiology. She went on to graduate in 1965 from Bryn Mawr, majoring in Russian literature, and spending her senior year in the Soviet Union.

She has been described as having been brought up in the communist movement in the U.S.. She worked in Cambridge Maryland in 1963 to desegregate a skating rink and several restaurants; in Cleveland as a community organizer, and during the summer of 1969 traveled along with Cathlyn Wilkerson and Ted Gold, who became an SDS-leader during the 1968 Columbia University riots, to communist Cuba for a meeting with officials of the Communist regime of North Viet Nam.

#### THE WEATHERMEN

The Weathermen were formed after an alleged organizational split occurred between their group and a large number of Progressive Labor Party members who were attempting to capture control of the national leadership of SDS. This split took place during the SDS national convention held in Chicago during the summer of 1969. That this alleged split was more fictional than factional becomes obvious when one considers the fact that as far back as 1968, individuals who were yet to become members of the Weathermen faction of SDS, conducted a workshop in Boulder Colorado for the purpose of instructing inner core members and leaders in the use of explosives and guerrilla warfare.

Following this Grandstand public display of a falling out with the Progressive Labor Party "faction", members of the newly formed Weathermen held a "War Council" in Flint Michigan. In attendance at the "War Council" were approximately 400 leaders and members of the group; also in attendance were several members of the Minutemen organization. Leaders of the group set down a new strategy for what they called a "well calculated guerrilla warfare", which was first begun in Chicago in October of 1968. The new strategy called for bombings, terrorism, and other acts of destruction. During the Flint Michigan get together additional instructions were given in pyrotechnics to those not present at the Boulder Colorado workshop.

During the "Days of Rage" demonstrations conducted by the Weathermen in Chicago, several other Minutemen were able to successfully procure through the art of serreptitious entry the notebooks of Cathlyn Wilkerson who was staying at one of the Weathermen's safe houses in Chicago.

At the Flint Michigan meeting and shortly afterwards, more than 500 of the Weathermen's 600 members were purged. In the process, they were successful in weeding out police and federal infiltrators and informants in their ranks. Fortunately, a number of Minutemen infiltrators were not discovered, since their identity was not even known to those in high government positions who would know the identity of government infiltrators. Thus these Minutemen could not be linked to any government agency. It would be safe to assume that it was from sources in the federal government that the Weathermen were able to get accurate information on the spies within their ranks.

One Minuteman, who worked independently as an infiltrator among New Left groups in the New York area for almost six years was invited to participate in the bomb making activities of the group who had set up shop at the Wilkerson residence. Possessing technical skill and knowledge which the academically inclined leftists lacked, he offered to provide them with the practical mechanics involved in using mercury switches for setting off high explosive charges.

Shortly after the would-be-terrorists accepted his generous offer, several of them received detailed instruction in the use of such mechanisms. Apparently preoccupied with romantic images of themselves, the students obviously failed to be attentive. The results of which are chronicled at the beginning of this article.

Many reading this might at first be inclined to feel the actions of this minuteman to have been callous or reprehensible. Others might consider them to be an extension of the practical joke carried to an extreme, however the motivations underlying his actions are to be found in the situation which he faced. Here was an individual confronted with making one of three difficult and

than detonate such devices in public were innocent men, women and children  
might by some quirk of fate, happen to be when one of their bombs went off.

It did not seem a wise move to this man to report what he knew to  
federal authorities, for he was aware that whenever something of this nature  
was done, such information was not acted upon, since those in charge were much  
more interested in Minuteman activities than anything illegal that leftists  
might be planning or had committed.

He also realized that had he given information to local law enforcement agencies, that even though they usually would take some action, that their work was compromised when the courts to which the arrested were brought before would pass the accused through the judicial filter which allows these chosen types to somehow never end up behind bars for their illegal acts.

Since the town house blast our Minuteman infiltrator has relocated himself, despite financial difficulties, to another part of the country fearing the chance that he might be recognized by leftists in New York who were formerly acquainted with him, or the even greater possibility that he might fall victim to government intelligence agencies if they learned of his identity and location.

We of the National Minuteman organization wish to take this opportunity to pass on our heart felt thanks to one more unknown individual, who with out constant direction, or continuous inspiration had the initiative, intelligence, and courage to cut through the Gorian Knot which confronted him with a single swift blow!

It was for an X - Ray taken. The amount of the bill was \$25.45. We give this information simply as something that anyone in doubt as to the veracity of our information reproduced here, can check up on.

In our next issue of On Target we will deal with further information on the Students For A Democratic Society and the Weathermen "Faction" at greater length. Included will be Membership lists of the National SDS organization.

#### LEGION OF JUSTICE

In the November Issue of On Target we suggested that anyone wishing to contribute to the legal defense of Thomas K. Stewart, a member of the Legion of Justice, could send contributions to the Legion of Justice's Post Office Box P.O Box 896, Elgin, Illinois. Since that time we have learned that the Box is rented by an individual known to have close connections with U.S. Military Intelligence, which operates out of Evanston, Illinois. This party infiltrated the Minutemen Organization, a number of years back for the U.S Army while still on active duty. He and other outcasts from the Minutemen organization quickly seized upon our generosity in giving an associate of theirs, space in our publication to help with legal expenses he faced. They quickly had Minutemen Stationary made up, giving the Elgin P.O. Box under our Minutemen emblem, claiming to be a "re - organized Minutemen, which was super - militant, and racist." A meeting of this group was held in Chicago in December, in attendance were less than a dozen individuals, and only a small number of these were actual members of the organization. Its spokesman Jessie Stephens, a bald, rotund, man, who, for all his bravado, would lack any natural gaiting and beer in hand before a late evening movie on television, than out in wilds leading guerrillas far from his refrigerator, spoke to UPI newsmen of how he Stephens was going to drop Robert DePugh as head of the Minutemen organization. Stephens was thrown out of the Minutemen organization some time ago, but yet continued to misrepresent himself as a Minuteman leader on the east coast. In June 1970 an open letter was sent to Stephens and members of the Minutemen organization, explaining that he was no longer considered a member of the Minutemen organization, this had little effect as he doggedly continued his divisive activities with the persistence that only

a psychopathically driven madman or a well trained obstinate federal agent would do. Stephens is evidently well banked for his role considering his ability to travel around the country contacting various people. Once again we are warning our members and friends to stay completely clear of this man and those connected with him, as he is a judas goat who will lead you eventually into the clutches of federal law enforcement mercenaries.

At present a nation wide campaign is being conducted against the Minutemen organization by federal authorities and government intelligence agencies, in an attempt to either take over the Minutemen organization or destroy it in the process. They are primarily interested in capturing the leadership positions, hoping to do much the same as they have done with the radical left and black militant groups. Once such a plan is realized by them they have their puppets in control of such groups turn the action off and on

depending on which benefits legislation they are currently attempting to get through. If its more gun laws their after, then militants are provoked into sniping on local policemen; if its tighter control of explosives, then the bombings start, such as we have seen over the past year or so. If they feel that the federal government hasn't enough local power at universities, then the riots must be turned on, but only until the F.B.I has gotten the job of policing them, and has had more funds appropriated for expansion of the number of agents on the payroll; then the riots miraculously cease over night. If its the first amendment that they feel is in their way, then the Jerry Ruebens', Abbie Hoffman's and Rap Browns' appear on the scene and give them the opening wedge by which new laws which have vague and broad interpretation are passed setting a precedent to taking away the individuals guarantee of freedom of speech. Once this has been accomplished, these devil's advocates having served their purpose are allowed off the hook with the lightest of sentences or probation; or like Rap Brown are allowed to escape or simply disappear. The laws they have helped put on the books however never disappear. When a real dissident such as Robert B. DePugh breaks one of these same laws he quickly finds that these laws are enforced with a vehemance never before witnessed in any other case.

Stephens and the Elgin group obviously are a part of a government attempt to draw off more militant elements of the Minutemen organization so that they can be lead and provoked into overt actions of a violent nature against the radical left. If they manage to do this on a wide enough scale, the claim will be made by the parasites that the country is in a state of civil warfare or on the brink of entering such a period. This of course means that all groups such as the Minutemen etc. will just have to be outlawed, and individuals belonging to such groups will have to be taken into custody since they are a threat to the internal security of the United States.

Those who allow themselves to be conned into this game will probably be allowed to get away with most of what they engage in, legal or illegal, but only so long as the parasites deem it desirable to their ends. Once the effect has been created, those fools who have been tricked into doing their dirty work will easily be rounded up and led off to the concentration camp.

We wish to make it clear that the National Minutemen organization headquartered in Norborne, Mo., has absolutely no ties, ideologically, organizationally, or spiritually with this minuscule element of renegades, provocateurs and dupes, and we accept no responsibility for any statements, actions, or trouble created by these people. We further wish to make it crystal clear to anyone cooperating with these people who finds himself in legal trouble stemming from association with this group, that we don't want you to come crawling back to us to cry on our shoulder, for in all fairness, we told you so.

If any of our members or associates are contacted by any of these people there is only one place they could have learned of your identity: from the government and its agencies. If this happens, consider yourself to be known to them and under surveillance. Let us know everything you can learn as soon as possible, so we can estimate the governments knowledge of our membership, and act in such a manner so as to seal up any further leaks.

Let's not let ourselves become impotent to the point that we become a part of a bogus resistance or revolution, which serves to disipate our strength and potential for being what we are intended to be - America's last line of defense. So lets all stay busy at present on gathering the material, acquiring the know-how and carefully laying our plans for the "Real Day".
