I do not know what else you plan but some of those who spend time in Washington use a local motel for several reasons, one being cost.


Most of those who stay in Frederick use The Red Horse Inn. It is 10 minutes from here and on the road to Washington. It has an 800 number.

It is with profound sincerity and a strong sense of civic responsibility that I request a meeting with you, at your convenience in the near future.

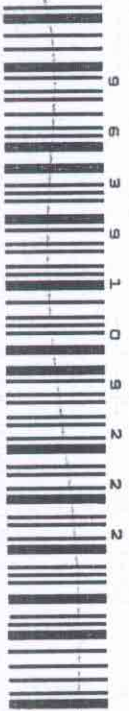
