Dear Mr. Henwood,

Your books are packaged and will be mailed as soon as we are no longer snowed and iced in. They will go by surface mail. Ordinarily this takes 2-3 weeks.

Some years ago I heard from people in the UK who had an interest in the JFK assassination at least one of whom published a newsletter but I've not heard from any of them in years and no longer remember their names. I believe the newsletter man was in Ireland.

The short answer to your question, will I respond to inquiries, is that I do. But I must impose some limitations. I explain them.

I am now 77 years old, with serious limitations on what I am able to do and with so much I want to do for which I have no time. My health is impaired, most recently from successful heart by-pass surgery. Thus I must impose some restrictions. First, I do not want to respond to questions that are answered in the books I've published and to which I can add nothing else.

The other limitation is that I will not waste any time on the multitudinous conspiracy-theory books all of which are seriously faulted and all of which in varying ways and degrees impose upon the trust of readers. They are often very persuasive and many are by some of the nicest people you'll ever meet by they are just plain wrong. Not all the authors of such books are innocent in their impositions on history and on sorrowing people, however.

It happens that most of the books of recent years do present untenable theories as solutions. There is nothing I can do about that and responding to questions about them has taken more time than I should have devoted to it. Most people long for a solution, for answers, and sometimes are unwilling to use their own critical faculties. If you have questions relating to those books I suggest you begin by asking yourself two questions. First, is this reasonable, and if it passes that test, is it possible. I know of ~~no~~ no book pretending to solve the assassination that passes these tests.

I hope you can understand why I must impose these limitations when concerned people ask questions. And I hope <sup>you see</sup> ~~also~~ that at this stage in my life everything I do is at the cost of something else I'll not be able to do.

The books I've written are a series, done in haste but nonetheless often assuming some reader knowledge of the preceding books. The first was intended to cover the Warren report to the degree then possible for me. You did not order it. I hope you have it because I cannot now take time to respond to questions I answered in it.
