Drop Obscenity Charge, Haggerty Attorney Asks

Quash Motion Filed, 17 Persons Subpoenaed

Attorney Robert J. Zibilich Wednesday asked that the obscenity charge against Judge Edward A. Haggerty Jr. be thrown out of court.

Zibilich filed a motion to quash the charge after having 17 persons subpoenaed to testify as defense witnesses during Haggerty's trial scheduled for 10 a.m. Monday before Criminal District Court Judge Matthew S. Braniff.

Judge Haggerty, who presides in another section of Criminal Court, is on vacation while facing charges of obscenity by exhibiting obscene movie film, soliciting for prostitutes. and resisting police officers.

The charges grew out of a Dec. 17 vice-squad raid on an alleged stag show in which the judge and 13 other persons were arrested.

In his motion to quash the obscenity charge Zibilich cited a U.S. Supreme Court decision in a federal case, Stanley vs. Georgia, which held that it is a man's right to view anything he wants to in his own home.

He contended that the gathering at the DeVille Motel, 3800 Tulane Ave., where the raid occurred, was private.

Zibilich has also contended in statements that the gathering was a before-the-wedding bachelor party for one of the guests.
