PATRICK told me of a Los Angeles area incident regarding LEE HARVEY OSWALD in 1959 that he apparently told the office many months ago. He said that shen CASTRO took over in Cuba on January 2, 1959, a group wearing 26 July Movement armbands took over the Cuban consulate in Monterrey Park. He said that Monterrey Park police investigators took photos and, among them, one showed LEE HARVEY OSWALD. PATRICK did not indicate that OSWALD was sympathetic or antagonistic to the 26 July people.

PATRICK said that on November 22, 1963, he was in Miami. When the news of the assassination flashed, he immediately thought of LORAN FUCENE Will. He had spoken with LESTER LORUE in Dallas one weck prior to the assassination and LOGUE told him (by phone) that HALL had returned. PATRICK said that LOGUE did not see MALL in Dallas after the week before the assassination.

He believes that he met <u>ARCACHA</u>, <u>BRINGUIER</u>, and <u>ED BUTLER</u> on one occasion each.
