PATRICK said that he was in GUY BANKSTAR'S office on one decasion and had set, at least ones, most of the New Orleans people who have come up in the case. He excepted FERRIS, SHAW, and many who were only witnesses. He knew MINE MOLARRY and LARRY LABORDE quite well and know RACEL, DAVIS, and BARTES somewhat well. He believes that he met GOACHA, DRIMOUTER, and ED TULKE on one occasion each. Unfortunately, he is so skeptical of the investigation's validity that he saw no point in talking about these people.

PATRICK said that the name THOMAS BECKHAM seemed familiar to him. His recalled that a person in Dallas, FRAMK WATERS, had a friend that may have been BECKHAM. He described 'BECK-kHAM.' briefly as 28-30 years old, light skin, medium hair,

PATRICK said that he had met CLINT VURCHISON, GORDON——

KENNADY, but he can recall no specific instance where MURA
CHISON, MCLENDON, or HUNT participated in this talk.

PATRICK advised that <u>FALLY WELCH</u> knew about almost everything that happened in Dallas relating to an ti-communist activism during the relevant period. He did not know if WELCH would talk to one of our investigators and did not know where he could be located. He did say that WELCH married oilman TEX FELLMAN'S daughter.

I asked PATRICK if he knew anyone who might be able to pass for LEE HARVEY OSWALD in appearance. He said that JOHN FLOCIER, an aids to ROBERT DE FUCH in St. Louis bore a physical resemblance to OSWALD. He also said that WILEY YATES a friend of HALL'S in Dallas, could possibly have passed.

PATRICK told me of a Los Angeles area incident regarding LEE HARVEY OSWALD in 1959 that he apparently told the office many months ago. He said that when CASTRO took over in Cuba on January 2, 1959, a group wearing 26 July Movement armbands took over the Cuban consulate in Monterrey Park. He said that Monterrey Park police investigators took photos and, among them, one showed LEE HARVEY OSWALD. PATRICK did not indicate that OSWALD was sympathetic or antagonistic to the 26 July people.

PATRICK said that on November 22, 1963, he was in Mizmi. When the news of the assassination flashed, he immediately thought of LORAN TAIGHT. Hall. He had spoken with LESTER LORGE in Dallas one week prior to the assassination and LOGUE told him (by phone) that HALL had returned. PATRICK said that LOGUE did not see HALL in Dallas after the week before the assassination.

PATRICK also advised that ED COLLING and ENRIQUE MOLINA (a Castro Spy) were in Dallas during Movember, 1963.
